## Details of Compulsory Testing Notice

### A. Specified premises under additional testing

1. Any person who had been present at Level 5 or 6, Terminal 1, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time on any day of June 4 to June 8, June 11, June 13 or June 15 to June 17, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 8, 2021. If persons subject to compulsory testing have previously undergone testing between July 4 and July 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Level 7, Terminal 1, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time on June 5 or June 17, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 8, 2021. If persons subject to compulsory testing have previously undergone testing between July 4 and July 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

### B. Others

*(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notices)*

1. Any person who had been present at Tsung Tsin Mission of Hong Kong On Yee Nursery School, G/F, Ko Shing House, Ko Yee Estate, Yau Tong, Kowloon, Hong Kong for more than two hours at any time during the period from June 23 to July 6, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by July 8, 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by July 10, 2021. If persons subject to compulsory testing have previously undergone testing between July 4 and July 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

<sup>1</sup> For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before June 24, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before June 24, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before June 24, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website ([www.coronavirus.gov.hk/pdf/list\\_of\\_recognised\\_covid19\\_vaccines.pdf](http://www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf)).
