**Details of Compulsory Testing Notice**

**A. Places visited by a non-locally confirmed case with L452R mutant strain**

1. Any person who had been present at 21/F, Tower 1, Kowloon Commerce Centre, 51 Kwai Cheong Road, Kwai Chung, New Territories, Hong Kong for more than one hour at any time on June 8, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Plaza Premium Lounge (Near Gate 1, Departure Hall), Level 6, Terminal 1, Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 6:00 p.m. to 8:00 p.m. on June 26, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Woolloomooloo Steakhouse, 31/F & Rooftop, The Hennessy, 256 Hennessy Road, Wan Chai, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on June 17, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at DiVino Patio - Ristorante Bar Pizzeria, Shop 11, 1/F, Brim 28, Causeway Centre, 28 Harbour Road, Wan Chai, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 21, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Cafe Locomotive Express, Shop 12, 4/F, Langham Place, 8 Argyle Street, Mong Kok, Kowloon, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 21, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously

undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

6. Any person who had been present at Dab-Pa Modern Chinese Cuisine, Shop 413-416, 4/F, Metroplaza, 223 Hing Fong Road, Kwai Fong, New Territories, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 22, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at pho.dle.bar, Shop 2132, 2/F, Elements, 1 Austin Road West, Tsim Sha Tsui, Kowloon, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on June 23, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
8. Any person who had been present at Happy Lamb Hot Pot, Portion of G/F-2/F, Concord Building, 60-104 Soy Street, Mong Kok, Kowloon, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 25, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
9. Any person who had been present at Oi Man Sang Kitchen, Shop B-C, G/F, 1 Shek Kip Mei Street, Sham Shui Po, Kowloon, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on June 25, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
10. Any person who had been present at Get together, G/F, 41 Tai Tsun Street, Tai Kok Tsui, Kowloon, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on June 22, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
11. Any person who had been present at Yung's Bistro, Shop 701, 7/F, K11 Musea, 18 Salisbury Road, Tsim Sha Tsui, Kowloon, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 23, 2021 (including but

not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

12. Any person who had been present at CHUAN Palace, Shop 501, 5/F, MOKO, 193 Prince Edward Road West, Mong Kok, Kowloon, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
13. Any person who had been present at Hong Kong Health Check & Medical Diagnostic Group Limited, 4/F, Hong Kong Health Check Tower, 241 - 243 Nathan Road, Jordan, Kowloon, Hong Kong at any time during the period from 4:00 p.m. to 6:00 p.m. on June 23, 2021 or 12:00 noon to 6:00 p.m. on June 25, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
14. Any person who had been present at Hong Kong Health Check & Medical Diagnostic Group Limited, 2/F, Hong Kong Health Check Tower, 241 - 243 Nathan Road, Jordan, Kowloon, Hong Kong at any time during the period from 10:00 a.m. to 12:00 noon on June 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## **B. Specified premises under additional testing**

Any person who had been present at Come Thai House Thai Food Restaurant, 1 Wong Nai Uk Village, Tung Chung, Lantau Island, New Territories, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on June 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 9, 2021. If persons subject to compulsory testing have previously undergone testing between July 5 and July 7, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
