# 8 July 2021 Details of Compulsory Testing Notice

### A. Places visited by a non-locally confirmed case with L452R mutant strain

- 1. Any person who had been present at Festival Grand Cinema, UG/F, Festival Walk, 80 Tat Chee Avenue, Kowloon Tong, Kowloon, Hong Kong for more than one hour at any time during the period from 11:00 a.m. to 1:00 p.m. on June 12, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 10, 2021. If persons subject to compulsory testing have previously undergone testing between July 6 and July 8, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Neptune Chiu Chow Restaurant (Golden Treasure), Shop UG1-UG12, UG/F, Waterside Plaza, 38 Wing Shun Street, Tsuen Wan, New Territories, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on June 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 10, 2021. If persons subject to compulsory testing have previously undergone testing between July 6 and July 8, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

# B. Places visited by a non-locally confirmed case who had transited through the Hong Kong International Airport

- 1. Any person who had been present at Plaza Premium Lounge (Near Gate 1, Departure Hall), Level 6, Terminal 1, Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 4:00 p.m. to 11:00 p.m. on June 14, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 10, 2021. If persons subject to compulsory testing have previously undergone testing between July 6 and July 8, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Plaza Premium Lounge (Near Gate 35, Departure Hall), Level 6, Terminal 1, Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 11:00 p.m. on June 14, 2021 to 7:00 a.m. on June 15, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 10, 2021. If persons subject to compulsory testing have previously undergone testing between July 6 and July 8, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## C. Specified premises under additional testing

- 1. Any person who had been present at Bluejay Residences, 95 Main Street Ap Lei Chau, Ap Lei Chau, Hong Kong at any time on June 9, June 10, June 13, June 19, June 21, June 22, June 23, June 24 or June 27, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by July 10, 2021. If persons subject to compulsory testing have previously undergone testing between July 6 and July 8, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Aberdeen Market, Aberdeen Municipal Services Building, 203 Aberdeen Main Road, Aberdeen, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 10, 2021. If persons subject to compulsory testing have previously undergone testing between July 6 and July 8, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at PARKnSHOP SUPERSTORE, G/F, Aberdeen Centre, 13-23 Nam Ning Street, Aberdeen, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 10, 2021. If persons subject to compulsory testing have previously undergone testing between July 6 and July 8, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 4. Any person who had been present at Sea East Restaurant, Shop 2 of G/F and Shop 3 of 1/F, Command Tower, 145 Main Street Ap Lei Chau, Ap Lei Chau, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 20, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 10, 2021. If persons subject to compulsory testing have previously undergone testing between July 6 and July 8, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

#### D. Others

(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notices)

1. Students of S.K.H. Kei Tak Primary School, Tai Shing Street, Wong Tai Sin, Kowloon, Hong Kong at Primary 6 and teachers (including but not limited to full-time, part-time and relief teachers) of the specified schools who had face-to-face lessons with such students at the specified levels during the period from June 25 to July 8, 2021 have to undergo testing by July 10, 2021. If persons subject to compulsory testing have previously undergone testing between July 6 and July 8, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice

For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before June 26, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before June 26, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before June 26, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this published the Government's COVID-19 thematic website purpose (www.coronavirus.gov.hk/pdf/list of recognised covid19 vaccines.pdf).
