**Details of Compulsory Testing Notice**

**A. Specified premises under additional testing**

1. Any person who had been present at Uptown Plaza (only the shopping mall is included), 9 Nam Wan Road, Tai Po, New Territories, Hong Kong at any time on June 3, June 9, June 12, June 13, June 15 to June 23, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 11, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 9, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Tai Po Mega Mall Zone C, 8 & 10 On Pong Road, Tai Po, New Territories, Hong Kong at any time during the period from 12:00 noon to 4:00 p.m. on June 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 11, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 9, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Tai Po Mega Mall Zone D, 8 & 10 On Pong Road, Tai Po, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 11, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 9, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at Fortune Plaza (only the shopping mall is included), 4 On Chee Road, Tai Po, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 22, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 11, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 9, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

5. Any person who had been present at Wan Tau Tong Shopping Centre, 10 Hiu Wan Road, Tai Po, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 21, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 11, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 9, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
6. Any person who had been present at Man Lee, Shop 15, G/F, Tai Po Plaza, 1 On Tai Road, Tai Po, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 11, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 9, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
7. Any person who had been present at House 2, 12A South Bay Road, Repulse Bay, Hong Kong at any time during the period from June 9 to July 1, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by July 11, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 9, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
8. Any person who had been present at Bridal Tea House Hotel, 6 Arthur Street & 5 Wing Sing Lane, Yau Ma Tei, Kowloon, Hong Kong at any time on June 14, June 16, June 17, June 28, June 30 or July 1, 2021 (including but not limited to full-time, parttime and relief staff, students and visitors), has to undergo testing by July 11, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 9, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
9. Any person who had been present at McDonald's, G/F, Shops 6A-6B, Site 4, Aberdeen Centre, Aberdeen, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 30, 2021 (including but not limited to fulltime, part-time and relief staff and visitors), has to undergo testing by July 11, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 9, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## **B. Others**

*(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notice)*

1. Any person who had been present at Yan Chai Hospital Kwok Chi Leung Kindergarten/Child Care Centre, UG/F (South), 9 High Street, Sai Ying Pun, Hong Kong for more than two hours at any time during the period from June 26 to July 9, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by July 11, 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by July 13, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 9, 2021, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

<sup>1</sup> For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before June 27, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before June 27, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before June 27, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website ([www.coronavirus.gov.hk/pdf/list\\_of\\_recognised\\_covid19\\_vaccines.pdf](http://www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf)).
