**Details of Compulsory Testing Notice**

1. Any person (including but not limited to full-time, part-time and relief staff) who, during the period from June 20 to July 10, 2021, has as his/her place of work at Terminal 1, Apron or Midfield Concourse of the Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong, has to undergo testing by July 13, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 10, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at McDonald's, Shop 13, 2/F, Block 3, Kwong Yuen Shopping Centre, 68 Siu Lek Yuen Road, Sha Tin, New Territories, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on July 9, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 13, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 10, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Maxim's MX, Shop G4B, G/F, Temple Mall South, 103 Ching Tak Street, Wong Tai Sin, Kowloon, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on July 9, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 13, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 10, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at The Leaf Kitchen, Shop 12, G/F, Block 3, Kwong Yuen Shopping Centre, 68 Siu Lek Yuen Road, Sha Tin, New Territories, Hong Kong at any time during the period from 7:00 a.m. to 12:00 noon on July 2, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 13, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 10, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Kam Sheung Tim, G/F, 52 Wan Fung Street, Wong Tai Sin, Kowloon, Hong Kong at any time during the period from 6:00 p.m. on June 29, 2021 to 0:00 a.m. on June 30, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 13, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 10, 2021, they would be

taken to have complied with the requirements set out in the compulsory testing notice.

6. Any person who had been present at Sushi Express, Shop 261, 2/F, Hsin Kuang Centre, 120 Lung Cheung Road, Wong Tai Sin, Kowloon, Hong Kong at any time during the period from 6:00 p.m. on June 26, 2021 to 0:00 a.m. on June 27, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 13, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 10, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
7. Any person who had been present at Ocean Park Hong Kong, 180 Wong Chuk Hang Road, Wong Chuk Hang, Hong Kong at any time during the period from 9:00 a.m. to 6:00 p.m. on June 26, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 13, 2021. If persons subject to compulsory testing have previously undergone testing between July 7 and July 10, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
