**Details of Compulsory Testing Notice**

**A. Place visited by a non-locally confirmed case involving L452R mutant strain**

1. Any person who had been present at the container ship “Maersk Lima” located at Kwai Tsing Container Terminals, New Territories, Hong Kong for more than one hour at any time during the period from July 13 to July 15, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 18, 2021. If persons subject to compulsory testing have previously undergone testing between July 14 and July 16, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

**B. Specified premises under additional testing**

1. Any person who had been present at McDonald's, G/F, Shops 6A-6B, Site 4, Aberdeen Centre, Aberdeen, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 30, 2021 (including but not limited to fulltime, part-time and relief staff and visitors), has to undergo testing by July 18, 2021. If persons subject to compulsory testing have previously undergone testing between July 14 and July 16, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Aberdeen Market, Aberdeen Municipal Services Building, 203 Aberdeen Main Road, Aberdeen, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 18, 2021. If persons subject to compulsory testing have previously undergone testing between July 14 and July 16, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at PARKnSHOP SUPERSTORE, G/F, Aberdeen Centre, 13-23 Nam Ning Street, Aberdeen, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 18, 2021. If persons subject to compulsory testing have previously undergone testing between July 14 and July 16, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

4. Any person who had been present at Kam Sheung Tim, G/F, 52 Wan Fung Street, Wong Tai Sin, Kowloon, Hong Kong at any time during the period from 6:00 p.m. on June 29, 2021 to 0:00 a.m. on June 30, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 18, 2021. If persons subject to compulsory testing have previously undergone testing between July 14 and July 16, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Ocean Park Hong Kong, 180 Wong Chuk Hang Road, Wong Chuk Hang, Hong Kong at any time during the period from 9:00 a.m. to 6:00 p.m. on June 26, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 18, 2021. If persons subject to compulsory testing have previously undergone testing between July 14 and July 16, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
6. Any person who had been present at Eat Together, G/F, 8 Ngan Fung Street, Wong Tai Sin, Kowloon, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on June 25, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 18, 2021. If persons subject to compulsory testing have previously undergone testing between July 14 and July 16, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
