**Details of Compulsory Testing Notice**

**A. Places visited by a non-local preliminary positive case involving L452R mutant strain**

1. Any person who had been present at Crypto.com, 15/F, Pacific Plaza, 418 Des Voeux Road West, Sai Wan, Hong Kong for more than one hour at any time on any day of June 28 to June 30 or 2 July, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 22, 2021. If persons subject to compulsory testing have previously undergone testing between July 17 and July 19, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Feather & Bone, Shop 1, G/F, Bohemian House, 321 Des Voeux Road West, Sai Ying Pun, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 30, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 22, 2021. If persons subject to compulsory testing have previously undergone testing between July 17 and July 19, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Cali-Mex Bar & Grill, G/F, 26 Hollywood Road, Central, Hong Kong at any time during the period from 6:00 p.m. on June 29, 2021 to 0:00 a.m. on June 30, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 22, 2021. If persons subject to compulsory testing have previously undergone testing between July 17 and July 19, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at ZUMA Hong Kong, Shop 501-503 on 5/F & Shop 601-603 on 6/F, Landmark Atrium, 15 Queen's Road Central, Central, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on June 27, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 22, 2021. If persons subject to compulsory testing have previously undergone testing between July 17 and July 19, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

**B. Specified premises under additional testing**

1. Any person who had been present at House 2, 12A South Bay Road, Repulse

Bay, Hong Kong at any time during the period from June 9 to July 1, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by July 22, 2021. If persons subject to compulsory testing have previously undergone testing between July 17 and July 19, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

2. Any person who had been present at Bridal Tea House Hotel, 6 Arthur Street & 5 Wing Sing Lane, Yau Ma Tei, Kowloon, Hong Kong at any time on June 14, June 16, June 17, June 28, June 30 or July 1, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 22, 2021. If persons subject to compulsory testing have previously undergone testing between July 17 and July 19, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person (including but not limited to full-time, part-time and relief staff) who, during the period from June 20 to July 10, 2021, has as his/her place of work at Terminal 1, Apron or Midfield Concourse of the Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong, has to undergo testing by July 22, 2021. If persons subject to compulsory testing have previously undergone testing between July 17 and July 19, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice. (See Note)
4. Any person who had been present at McDonald's, Shop 13, 2/F, Block 3, Kwong Yuen Shopping Centre, 68 Siu Lek Yuen Road, Sha Tin, New Territories, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on July 9, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 22, 2021. If persons subject to compulsory testing have previously undergone testing between July 17 and July 19, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Maxim's MX, Shop G4B, G/F, Temple Mall South, 103 Ching Tak Street, Wong Tai Sin, Kowloon, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on July 9, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 22, 2021. If persons subject to compulsory testing have previously undergone testing between July 17 and July 19, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
6. Any person who had been present at Gin Curry, Shop G7, G/F, Temple Mall South, 103 Ching Tak Street, Wong Tai Sin, Kowloon, Hong Kong at any time during the period from 6:00 p.m. on July 8, 2021 to 0:00 a.m. on July 9, 2021 (including but not limited to full-time, part-time and relief staff and visitors),

has to undergo testing by July 22, 2021. If persons subject to compulsory testing have previously undergone testing between July 17 and July 19, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

7. Any person who had been present at Hair Salon, G/F, 132 Kiu Kiang Street, Sham Shui Po, Kowloon, Hong Kong at any time during the period from 10:00 a.m. to 1:00 p.m. on July 9, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 22, 2021. If persons subject to compulsory testing have previously undergone testing between July 17 and July 19, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

**C. Persons who have as their usual place of work at the Hong Kong International Airport**

1. Any person (including but not limited to full-time, part-time and relief staff) who, during the period from July 25 to July 31, 2021, has as his/her place of work at Terminal 1, Apron or Midfield Concourse of the Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong, has to undergo testing by July 24, 2021. (See Note)

Note: If persons subject to compulsory testing have undergone testing between July 19 and July 22, 2021, they would be taken to have complied with the requirements of the Compulsory Testing Notices set out in Item B3 and Item C1.
