Details of Compulsory Testing Notice

A. Places visited by preliminary positive case and confirmed cases involving L452R mutant strain

1. Any person who had been present at Spring Moon, 1/F, The Peninsula Hong Kong, Salisbury Road, Tsim Sha Tsui, Kowloon, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on July 2, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 23, 2021. If persons subject to compulsory testing have previously undergone testing between July 18 and July 20, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Uma Nota, Shop C, G/F, 38 Peel Street, Soho, Central, Hong Kong at any time during the period from 5:00 p.m. to 10:00 p.m. on July 1, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 23, 2021. If persons subject to compulsory testing have previously undergone testing between July 18 and July 20, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Sushi Shikon, 7/F, The Landmark Mandarin Oriental, Hong Kong, The Landmark, 15 Queen's Road Central, Central, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on June 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 23, 2021. If persons subject to compulsory testing have previously undergone testing between July 18 and July 20, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at Ask For Alonzo, Shop 19, G/F, Hang Fung Mansion, 17-19 Wong Nai Chung Road, Happy Valley, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 23, 2021. If persons subject to compulsory testing have previously undergone testing between July 18 and July 20, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

5. Any person who had been present at Salisterra, 49/F, The Upper House, Pacific Place, 88 Queensway, Admiralty, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 23, 2021. If persons subject to compulsory testing have previously undergone testing between July 18 and July 20, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
6. Any person who had been present at MO Bar, G/F, The Landmark Mandarin Oriental Hotel, Hong Kong, The Landmark, 15 Queen's Road Central, Central, Hong Kong at any time during the period from 5:00 p.m. to 10:00 p.m. on June 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 23, 2021. If persons subject to compulsory testing have previously undergone testing between July 18 and July 20, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
7. Any person who had been present at Grand Club, 30/F & 31/F, Grand Hyatt Hong Kong, 1 Harbour Road, Wan Chai, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 23, 2021. If persons subject to compulsory testing have previously undergone testing between July 18 and July 20, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
8. Any person who had been present at The Peak Galleria (the bus terminus is excluded), 118 Peak Road, The Peak, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on July 17, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 23, 2021. If persons subject to compulsory testing have previously undergone testing between July 18 and July 20, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
9. Any person who had been present at Citygate (only the shopping mall is included), 18-20 Tat Tung Road & 41 Man Tung Road, Tung Chung, Lantau Island, New Territories, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on July 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 23, 2021. If persons subject to compulsory testing have previously undergone testing between July 18 and July 20, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

10. Any person who had been present at Tung Chung Cable Car Terminal, Tung Chung, Lantau Island, New Territories, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on July 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 23, 2021. If persons subject to compulsory testing have previously undergone testing between July 18 and July 20, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Specified premises under additional testing

1. Any person who had been present at The Leaf Kitchen, Shop 12, G/F, Block 3, Kwong Yuen Shopping Centre, 68 Siu Lek Yuen Road, Sha Tin, New Territories, Hong Kong at any time during the period from 7:00 a.m. to 12:00 noon on July 2, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by July 23, 2021. If persons subject to compulsory testing have previously undergone testing between July 18 and July 20, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
