## 2 August 2021 Details of Compulsory Testing Notice

## A. Places visited by the preliminary positive cases involving L452R/N501Y mutant strains

- 1. Any person who had been present at Tower 6, Harbour Place, 8 Oi King Street, Hung Hom, Kowloon, Hong Kong for more than two hours at any time during the period from July 10 to August 1, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by August 3, 2021. If persons subject to compulsory testing have previously undergone testing between July 30 and August 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Bohemian House, 321 Des Voeux Road West, Sai Ying Pun, Hong Kong for more than two hours at any time during the period from July 11 to August 1, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by August 3, 2021. If persons subject to compulsory testing have previously undergone testing between July 30 and August 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at Euler Hermes Hong Kong Services Limited, Suites 403-411, 4/F, Cityplaza 4, 12 Taikoo Wan Road, Quarry Bay, Hong Kong for more than one hour at any time during the period from July 11 to August 1, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 3, 2021. If persons subject to compulsory testing have previously undergone testing between July 30 and August 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 4. Any person who had been present at SOZO Hair Design, 3/F, World-wide Commercial Building, 34 Wyndham Street, Central, Hong Kong for more than one hour at any time during the period from 6:00 p.m. to 9:00 p.m. on July 15, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 3, 2021. If persons subject to compulsory testing have previously undergone testing between July 30 and August 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 5. Any person who had been present at Nha Trang Vietnamese Cuisine, Shop G512-G513, Shun On Mansion, On Shing Terrace, 3 Tai Yue Avenue, Quarry Bay, Hong Kong for more than one hour at any time during the period from 12:00 nn to 2:00 p.m. on July 15, 2021 (including but not limited to full-time,

part-time and relief staff and visitors), has to undergo testing by August 3, 2021. If persons subject to compulsory testing have previously undergone testing between July 30 and August 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

- 6. Any person who had been present at CrossFit Cavaliers, G/F, 533-537 Queen's Road West, Shek Tong Tsui, Hong Kong for more than one hour at any time during the period from 6:00 a.m. to 9:00 a.m. on July 13 or July 15, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 3, 2021. If persons subject to compulsory testing have previously undergone testing between July 30 and August 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 7. Any person who had been present at LOCKCHA, Shop G06-07, Block 01, Tai Kwun, 10 Hollywood Road, Central, Hong Kong for more than one hour at any time during the period from 6:00 p.m. to 8:00 p.m. on July 11, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 3, 2021. If persons subject to compulsory testing have previously undergone testing between July 30 and August 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 8. Any person who had been present at Chaiwala, Basement, 43-55 Wyndham Street, Central, Hong Kong for more than one hour at any time during the period from 2:00 p.m. to 6:00 p.m. on July 11, 2021 (including but not limited to fulltime, part-time and relief staff and visitors), has to undergo testing by August 3, 2021. If persons subject to compulsory testing have previously undergone testing between July 30 and August 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## B. Place visited by a non-locally confirmed case

(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notices)

If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before July 20, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before July 20, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before July 20, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 (www.coronavirus.gov.hk/pdf/list of recognised covid19 vaccines.pdf).

1. Any person who had been present at Lok Yuen, 24 College Road & 16 Sau Chuk Yuen Road, Kowloon City, Kowloon, Hong Kong for more than two hours at any time during the period from July 4 to August 1, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by August 3, 2021. If persons subject to compulsory testing have previously undergone testing between July 30 and August 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
