

**Boarding and Compulsory Quarantine Arrangements for Persons Arriving in Hong Kong from Places Outside China**

(With effect from August 9, 2021)

<b>Group A specified places (High-risk)</b>		
Specified places:	Brazil, India, Indonesia, Ireland, Nepal, Pakistan, the Philippines, Russia, South Africa and the United Kingdom	
Persons applicable:	Hong Kong residents who have stayed in Group A specified place(s) on the day of boarding for/arrival in Hong Kong or during the 21 days before that day and who –	
	<b>do not hold recognised vaccination record<sup>i</sup></b>	<b>have been fully vaccinated and hold recognised vaccination record</b>
Boarding requirement:	(a) Have not stayed in the relevant specified places for more than two hours during the relevant period; (b) Present negative result proof of a polymerase chain reaction (PCR)-based nucleic acid test for COVID-19 conducted within 72 hours before the scheduled time of departure of the aircraft <sup>ii</sup> ; and (c) Present confirmation of room reservation for 21 nights starting on the day of arrival in a designated quarantine hotel (DQH)	(a) Present recognised vaccination record <sup>i</sup> (b) Present negative result proof of a PCR-based nucleic acid test for COVID-19 conducted within 72 hours before the scheduled time of departure of the aircraft <sup>ii</sup> ; and (c) Present confirmation of room reservation for 21 nights starting on the day of arrival in a DQH
Quarantine requirement:	(a) Undergo compulsory quarantine for 21 days in a DQH; (b) Undergo 4 tests during compulsory quarantine; (c) Self-monitoring in the subsequent 7 days; and (d) Undergo compulsory testing in a Community Testing Centre on the 26 <sup>th</sup> day of arrival in Hong Kong	

<b>Group B specified places (Medium-risk)</b>			
Specified places:	All places outside China which are not Group A or Group C specified places		
Persons applicable:	Travellers who have stayed in Group B specified place(s) on the day of boarding for/arrival in Hong Kong or during the 14 days before that day and who –		
	are Hong Kong residents, and who –	are Hong Kong residents or non-Hong Kong residents, and who –

<b>Group C specified places (Low-risk)</b>		
Specified places:	Australia and New Zealand	
Persons applicable:	Hong Kong residents and non-Hong Kong residents who have only stayed in Group C specified place(s), the Mainland or Macao during the day of boarding for/arrival in Hong Kong or during the 14 days before that day and who –	
	<b>have not been fully vaccinated</b>	<b>have been fully vaccinated</b>
Boarding requirement:	(a) Present negative result proof of a PCR-based nucleic acid test for COVID-19 conducted within 72 hours before the scheduled time of departure of the aircraft <sup>ii</sup> ; and (b) Present confirmation of room reservation for 14 nights starting on the day of arrival in a DQH	(a) Present negative result proof of a PCR-based nucleic acid test for COVID-19 conducted within 72 hours before the scheduled time of departure of the aircraft <sup>ii</sup> ; (b) Present confirmation of room reservation for 7 nights starting on the day of arrival in a DQH; and (c) Present vaccination record <sup>iii</sup>
Quarantine requirement:	(a) Undergo compulsory quarantine for 14 days in a DQH; (b) Undergo 3 tests during compulsory quarantine; (c) Self-monitoring in the subsequent 7 days; and (d) Undergo compulsory testing on the 16 <sup>th</sup> and 19 <sup>th</sup> days of arrival in Hong Kong	(a) Undergo compulsory quarantine for 7 days in a DQH; (b) Undergo 2 tests during compulsory quarantine; (c) Self-monitoring in the subsequent 7 days; and (d) Undergo compulsory testing on the 9 <sup>th</sup> and 12 <sup>th</sup> days of arrival in Hong Kong

<sup>i</sup> Recognised vaccination record should include:

- (a) A vaccination record issued by a healthcare institution or a relevant authority of the Government of Hong Kong, the Mainland, or a country where its national regulatory authority is designated by the World Health Organization as a stringent regulatory authority, bearing the name of the relevant vaccinated traveller matching that in his/her valid travel document to show in Chinese or English that:
  - (i) the relevant traveller has received dose(s) of COVID-19 vaccine and the date on which the last dose was administered; and
  - (ii) the name of the vaccine administered; and
- (b) A written confirmation in English or Chinese issued by the healthcare institution or a relevant authority of the government of the place where the vaccine was administered, bearing the name of the relevant vaccinated traveller matching that in his/her valid travel document and setting out all of the above information if the vaccination record is not in English or Chinese or does not contain all of the above information. The said written confirmation should be presented together with the vaccination record.

<sup>ii</sup> Negative result proof of PCR-based nucleic acid test for COVID-19 should include:

- (a) A test report in English or Chinese issued by a laboratory or healthcare institution

- bearing the name of the relevant traveller matching that in his or her valid travel document to show that:
- (i) the relevant traveller underwent a nucleic acid test for COVID-19, the sample for which was taken from the relevant traveller within 72 hours before the scheduled time of departure of the specified aircraft;
  - (ii) the test conducted on the sample is a polymerase chain reaction-based nucleic acid test for COVID-19; and
  - (iii) the relevant traveller was tested negative for COVID-19; and
- (b) If the relevant report is not in English or Chinese or does not contain all of the above information, a written confirmation in English or Chinese issued by the laboratory or healthcare institution bearing the name of the relevant traveller matching that in his or her valid travel document and setting out all of the above information. The said written confirmation should be presented together with the test report; and
- (c) Documentary proof in English or Chinese to show that the laboratory or healthcare institution is ISO 15189 accredited or is recognised or approved by the relevant authority of the government of the place in which the laboratory or healthcare institution is located.
- iii Vaccination record should include:
- (a) A vaccination record in English or Chinese issued by a healthcare institution or a relevant authority of the government of the place where the vaccine was administered, bearing the name of the relevant vaccinated traveller matching that in his/her valid travel document to show that:
    - (i) the relevant traveller has received dose(s) of COVID-19 vaccine and the date on which the last dose was administered; and
    - (ii) the name of the vaccine administered; and
  - (b) A written confirmation in English or Chinese issued by the healthcare institution or a relevant authority of the government of the place where the vaccine was administered, bearing the name of the relevant vaccinated traveller matching that in his/her valid travel document and setting out all of the above information if the vaccination record is not in English or Chinese or does not contain all of the above information. The said written confirmation should be presented together with the vaccination record.
