4 August 2021 Details of Compulsory Testing Notice

A. Places visited by a local preliminary positive case which is suspected to be re-positive

- 1. If persons subject to compulsory testing have previously undergone testing between August 2 and August 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Place visited by a close contact of a non-locally confirmed case

Any person who had been present at the cross-boundary shuttle bus drop-off area (arrival level) of the Hong Kong-Zhuhai-Macao Bridge Hong Kong Port for more than one hour at any time during the period from 12:00 noon to 4:00 p.m. on August 2, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 6, 2021. If persons subject to compulsory testing have previously undergone testing between August 2 and August 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at the southern Public Transport Interchange of the Hong Kong-Zhuhai-Macao Bridge Hong Kong Port for more than one hour at any time during the period from 12:00 noon to 4:00 p.m. on August 2, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 6, 2021. If persons subject to compulsory testing have previously undergone testing between August 2 and August 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at 7/F, Immigration Tower, 7 Gloucester Road, Wan Chai, Hong Kong for more than one hour at any time during the period from 11:00 a.m. to 4:00 p.m. on August 3, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 6, 2021. If persons subject to compulsory testing have previously undergone testing between August 2 and August 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 4. Any person who had been present at Lok Wah Kitchen, Shops 1-2, G/F, 110-116 Jaffe Road, Wan Chai, Hong Kong for more than one hour at any time during the period from 12:00 noon to 2:00 p.m. on August 3, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 6, 2021. If persons subject to compulsory testing have previously undergone testing between August 2 and August 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Mannings, G/F, Po On Commercial Building, 198 Nathan Road, Jordan, Kowloon, Hong Kong for more than one hour at any time during the period from 2:00 p.m. to 6:00 p.m. on August 3, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 6, 2021. If persons subject to compulsory testing have previously undergone testing between August 2 and August 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 7. Any person who had been present at Gyu-Kaku Buffet, Shops G08-G09, G/F, Mira Place One, 132 Nathan Road, Tsim Sha Tsui, Kowloon, Hong Kong for more than one hour at any time during the period from 6:00 p.m. to 10:00 p.m. on August 2, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 6, 2021. If persons subject to compulsory testing have previously undergone testing between August 2 and August 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
