Details of Compulsory Testing Notice

A. Places visited by a local confirmed case which is suspected to be re-positive

1. Any person who had been present at the restaurant at 1/F, Ho Chuck Centre, New Kwai Fong Gardens, Kwai Yi Road, Kwai Fong, New Territories, Hong Kong at any time during the period from 7:00 a.m. to 9:00 a.m. on July 27, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 8, 2021. If persons subject to compulsory testing have previously undergone testing between August 3 and August 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Places visited by a non-locally confirmed case

(Persons who have completed a COVID-19 vaccination course¹ would be taken to have complied with the requirements set out in the compulsory testing notices)

1. Any person who had been present at Pan Pacific Retail Management (Hong Kong) Co., Limited, Unit 2107, 21/F, Tower A, Mira Place, 132 Nathan Road, Tsim Sha Tsui, Kowloon, Hong Kong for more than two hours at any time during the period from July 16 to July 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 8, 2021. If persons subject to compulsory testing have previously undergone testing between August 3 and August 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at The Premier (Block 6), Chianti, Discovery Bay, Lantau Island, New Territories, Hong Kong for more than two hours at any time during the period from July 16 to August 5, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by August 8,

¹ If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before July 25, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before July 25, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before July 25, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website (www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf).

2021. If persons subject to compulsory testing have previously undergone testing between August 3 and August 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice

C. Specified premises under additional testing

1. Any person who had been present at The Peak Galleria (the bus terminus is excluded), 118 Peak Road, The Peak, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on July 17, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 8, 2021. If persons subject to compulsory testing have previously undergone testing between August 3 and August 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Citygate (only the shopping mall is included), 18-20 Tat Tung Road & 41 Man Tung Road, Tung Chung, Lantau Island, New Territories, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on July 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 8, 2021. If persons subject to compulsory testing have previously undergone testing between August 3 and August 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Tung Chung Cable Car Terminal, Tung Chung, Lantau Island, New Territories, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on July 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 8, 2021. If persons subject to compulsory testing have previously undergone testing between August 3 and August 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
