## 6 August 2021 Details of Compulsory Testing Notice

## A. Places visited by a preliminary positive case involving L452R mutant strain

- 1. Any person who had been present at WeWork, 7/F & 8/F, Bonham Circus, 40-44 Bonham Strand, Sheung Wan, Hong Kong for more than two hours at any time during the period from July 15 to July 25, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Elephant Grounds, G/F, Hollywood Centre, 233 Hollywood Road, Sheung Wan, Hong Kong at any time during the period from 12:00 noon to 4:00 p.m. on July 25, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at Posto Pubblico, G/F, Million City, 28 Elgin Street, Central, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on July 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 4. Any person who had been present at Starting Over Espresso, G/F, 17 Old Bailey Street, Central, Hong Kong at any time during the period from 11:00 a.m. to 3:00 p.m. on July 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 5. Any person who had been present at BIG SUR, G/F, 22 Staunton Street, Central, Hong Kong at any time during the period from 7:00 p.m. to 11:00 p.m. on July 23, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

- 6. Any person who had been present at MindnLife Limited, Suite 1202, 12/F, Chinachem Hollywood Centre, 1-13 Hollywood Road, Central, Hong Kong at any time during the period from 11:00 a.m. to 12:00 noon on July 21, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 7. Any person who had been present at 298 Nikuya Room, 2/F, Pearl Oriental House, 60 Stanley Street, Central, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on July 21, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 8. Any person who had been present at Crystal Jade La Mian Xiao Long Bao, Shop 2018-2020, Level 2, International Finance Centre Mall, Central, Hong Kong at any time during the period from 1:00 p.m. to 5:00 p.m. on July 20, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 9. Any person who had been present at The Roastery X, Shop G707, G/F, Square Mile, 18 Ka Shin Street, Tai Kok Tsui, Kowloon, Hong Kong at any time during the period from 5:00 p.m. to 9:00 p.m. on July 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 10. Any person who had been present at Bosom Hainan Chicken, G/F, 109 Hennessy Road, Wan Chai, Hong Kong at any time during the period from 1:00 p.m. to 5:00 p.m. on July 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 11. Any person who had been present at the 31<sup>st</sup> Hong Kong Book Fair, Hong Kong Convention and Exhibition Centre, 1 Harbour Road, Wan Chai, Hong Kong at any time during the period from 11:00 a.m. to 2:00 p.m. on July 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory

testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

12. Any person who had been present at Pici, Shop 5-9, G/F, Hang Yu Building, 45-55 Cadogan Street, Kennedy Town, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on July 17, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## B. Places visited by a non-locally confirmed case

(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notices)

1. Any person who had been present at DON DONKI, Shop 2001, 2/F, Ocean Pride Mall, 100 Tai Ho Road, Tsuen Wan, New Territories, Hong Kong for more than two hours at any time on July 13, July 21, July 27 or July 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## C. Specified premises under additional testing

1. Any person who had been present at Cityplaza (only shopping mall is included), Quarry Bay, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on July 18, from 6:00 p.m. to 10:00 p.m. on July 19 or from 12:00 noon to 6:00 p.m. on July 20, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before July 26, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before July 26, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before July 26, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the COVID-19 Government's thematic website (www.coronavirus.gov.hk/pdf/list of recognised covid19 vaccines.pdf).

- 2. Any person who had been present at Food le Parc, Shop 2-3, G/F, Westlands Centre, 20 Westlands Road, Quarry Bay, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on July 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at Quarry Bay Park Phase I, Quarry Bay, Hong Kong at any time during the period from 1:00 p.m. to 3:00 p.m. on July 17, from 5:00 p.m. to 7:00 p.m. on July 17 or from 4:00 p.m. to 6:00 p.m. on July 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 4. Any person who had been present at the tents outside the main entrance on G/F or the urgent care room of Hong Kong Adventist Hospital, 40 Stubbs Road, Mid-levels, Hong Kong at any time during the period from 4:00 p.m. to 6:00 p.m. on July 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 9, 2021. If persons subject to compulsory testing have previously undergone testing between August 4 and August 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
