Details of Compulsory Testing Notice

A. Persons who had come into contact or handled the fish sold by a specified fish stall

1. Any person (including but not limited to full-time, part-time and relief staff and customers) who, during the period from August 10 to August 12, 2021, had come into contact or handled the fish sold by the fish stall 華記鮮魚 at No. 4, 1/F, To Kwa Wan Market, 165 Ma Tau Wai Road, To Kwa Wan, Kowloon, Hong Kong has to undergo testing by August 14, 2021. If persons subject to compulsory testing have previously undergone testing between August 10 and August 12, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Specified premises under additional testing

1. Any person who had been present at WeWork, 7/F & 8/F, Bonham Circus, 40-44 Bonham Strand, Sheung Wan, Hong Kong for more than two hours at any time during the period from July 15 to July 25, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 14, 2021. If persons subject to compulsory testing have previously undergone testing between August 10 and August 12, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Elephant Grounds, G/F, Hollywood Centre, 233 Hollywood Road, Sheung Wan, Hong Kong at any time during the period from 12:00 noon to 4:00 p.m. on July 25, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 14, 2021. If persons subject to compulsory testing have previously undergone testing between August 10 and August 12, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Posto Pubblico, G/F, Million City, 28 Elgin Street, Central, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on July 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 14, 2021. If persons subject to compulsory testing have previously undergone testing between August 10 and August 12, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

4. Any person who had been present at Starting Over Espresso, G/F, 17 Old Bailey Street, Central, Hong Kong at any time during the period from 11:00 a.m. to 3:00 p.m. on July 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 14, 2021. If persons subject to compulsory testing have previously undergone testing between August 10 and August 12, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
