Any person who had been present at 3hreesixty, Shop 201-203, 2/F, Stanley Plaza, 23 Carmel Road, Stanley, Hong Kong at any time during the period from 12:00 noon to 3:00 p.m. on August 9 or 12:00 noon to 3:00 p.m. on August 11, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 15, 2021.
