**Details of Compulsory Testing Notice**

1. Any person who had been present at Ngan Lung Restaurant, Shop G03, G/F, Plaza 328, 328 Sha Tsui Road, Tsuen Wan, New Territories, Hong Kong at any time during the period from 2:00 p.m. to 7:00 p.m. on August 1 or from 3:00 p.m. to 6:00 p.m. on August 15, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 24, 2021. If persons subject to compulsory testing have previously undergone testing between August 20 and August 22, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

If persons subject to compulsory testing have previously undergone testing between August 20 and August 22, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

If persons subject to compulsory testing have previously undergone testing between August 20 and August 22, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Restaurant 若男冰室, Shop 1, G/F, Trust Centre, 912-914 Cheung Sha Wan Road, Lai Chi Kok, Kowloon, Hong Kong at any time during the period from 9:00 a.m. to 11:00 a.m. on August 14, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 24, 2021. If persons subject to compulsory

testing have previously undergone testing between August 20 and August 22, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

If persons subject to compulsory testing have previously undergone testing between August 20 and August 22, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Eat Together, G/F, 1G-1H Wing Sing Lane, Yau Ma Tei, Kowloon, Hong Kong at any time during the period from 3:00 p.m. to 9:00 p.m. on August 7, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 24, 2021. If persons subject to compulsory testing have previously undergone testing between August 20 and August 22, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Restaurant 權記雲吞麵, G/F, 303 Queen's Road Central, Sheung Wan, Hong Kong at any time during the period from 6:00 p.m. to 9:00 p.m. on August 7, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 24, 2021. If persons subject to compulsory testing have previously undergone testing between August 20 and August 22, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

If persons subject to compulsory testing have previously undergone testing between August 20 and August 22, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at U-Banquet The Starview (Kwun Tong), 2/F, Crocodile Center, 79 Hoi Yuen Road, Kwun Tong, Kowloon, Hong Kong at any time during the period from 1:00 p.m. to 6:00 p.m. on August 5, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 24, 2021. If persons subject to compulsory testing have previously undergone testing between August 20 and August 22, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Diagon Alley, Shop F12, 1/F, The Cube, 122-132A Hoi Pa Street, Tsuen Wan, New Territories, Hong Kong at any time during the period from 1:00 p.m. to 1:30 p.m. on August 3, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 24, 2021. If persons subject to compulsory testing have previously undergone testing between August 20 and August 22, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
