如何核證疫苗紀錄真確性 How to verify the authenticity of the vaccination record

- (a) 瀏覽菲律賓檢疫局網址(<u>https://icv.boq.ph</u>)或下載菲律賓檢疫局應用程式 「BOQ OBS」(如圖 1)。
- (b) 按「核實檢疫局證書」, 打開掃描器(如圖2)。
 - 掃描「黃皮書」內的二維碼。
 - 確認疫苗接種資料與「黃皮書」內的資料相同(如圖3)。
- (a) Visit the Website of BOQ of the Philippines (<u>https://icv.boq.ph</u>) or Download the Application of BOQ of the Philippines "BOQ OBS" (see Picture 1).
- (b) Click the Button "VERIFY BOQ CERTIFICATE" to open the BOQ QR Scanner Application (see Picture 2)
 - Scan the QR Code on the "Yellow Card".
 - Confirm that the vaccination information is the same as that on the "Yellow Card" (see Picture 3).
