## 28 August 2021 Details of Compulsory Testing Notice

## A. Places visited by the a preliminary positive case involving L452R mutant strain

- 1. Any person who had been present at Pascucci, Shop G03, G/F, D'Deck, Discovery Bay, Lantau Island, New Territories, Hong Kong at any time during the period from 2:00 p.m. to 7:30 p.m. on August 4 or August 5, from 12:00 noon to 5:00 p.m. on August 7 or August 8, from 10:30 a.m. to 3:00 p.m. on August 10 or August 11, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 30, 2021. If persons subject to compulsory testing have previously undergone testing between August 26 and August 28, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at McDonald's, Shop No. G02, G/F, Block A, D.B. Plaza, Discovery Bay, Lantau Island, New Territories, Hong Kong at any time during the period from 2:30 p.m. to 4:00 p.m. on August 11 or August 12 or from 10:30 a.m. to 12:00 noon on August 15, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 30, 2021. If persons subject to compulsory testing have previously undergone testing between August 26 and August 28, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at Hong Kong Maritime Museum, Central Pier No. 8, Hong Kong at any time during the period from 12:00 noon to 5:00 p.m. on August 14, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 30, 2021. If persons subject to compulsory testing have previously undergone testing between August 26 and August 28, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 4. Any person who had been present at Sunrise, 3 Parkridge Crescent, Discovery Bay, Lantau Island, New Territories, Hong Kong at any time during the period from August 4 to August 28, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by August 30, 2021. If persons subject to compulsory testing have previously undergone testing between August 26 and August 28, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## B. Place visited by the non-locally confirmed cases

Any person who had been present at Hong Kong Football Club Coffee Shop, 2/F, Hong Kong Football Club, 3 Sports Road, Happy Valley, Hong Kong at any time during the period from 7:30 a.m. to 11:30 a.m. on August 27, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 30, 2021. If persons subject to compulsory testing have previously undergone testing between August 26 and August 28, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Plaza Premium Lounge (near Gate 1), Level 6, Departures Level, Terminal 1, Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 7:00 a.m. to 3:00 p.m. on August 25, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 30, 2021. If persons subject to compulsory testing have previously undergone testing between August 26 and August 28, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at 208 Shek O Village, Shek O, Hong Kong at any time during the period from August 26 to August 28, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by August 30, 2021. If persons subject to compulsory testing have previously undergone testing between August 26 and August 28, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## C. Specified premises under additional testing

If persons subject to compulsory testing have previously undergone testing between August 26 and August 28, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at 3hreesixty, Shop 201-203, 2/F, Stanley Plaza, 23 Carmel Road, Stanley, Hong Kong at any time during the period from 12:00 noon to 3:00 p.m. on August 9 or 12:00 noon to 3:00 p.m. on August 11, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by August 30, 2021. If persons subject to

compulsory testing have previously undergone testing between August 26 and August 28, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had taken any of green minibuses running on route number 40 from Stanley Village to Causeway Bay at any time during the period from 3:30 p.m. to 5:00 p.m. on August 8, 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by August 30, 2021. If persons subject to compulsory testing have previously undergone testing between August 26 and August 28, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had taken any of green minibuses running on route number 40 from Causeway Bay to Stanley Village at any time during the period from 6:30 p.m. to 8:00 p.m. on August 8, 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by August 30, 2021. If persons subject to compulsory testing have previously undergone testing between August 26 and August 28, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
