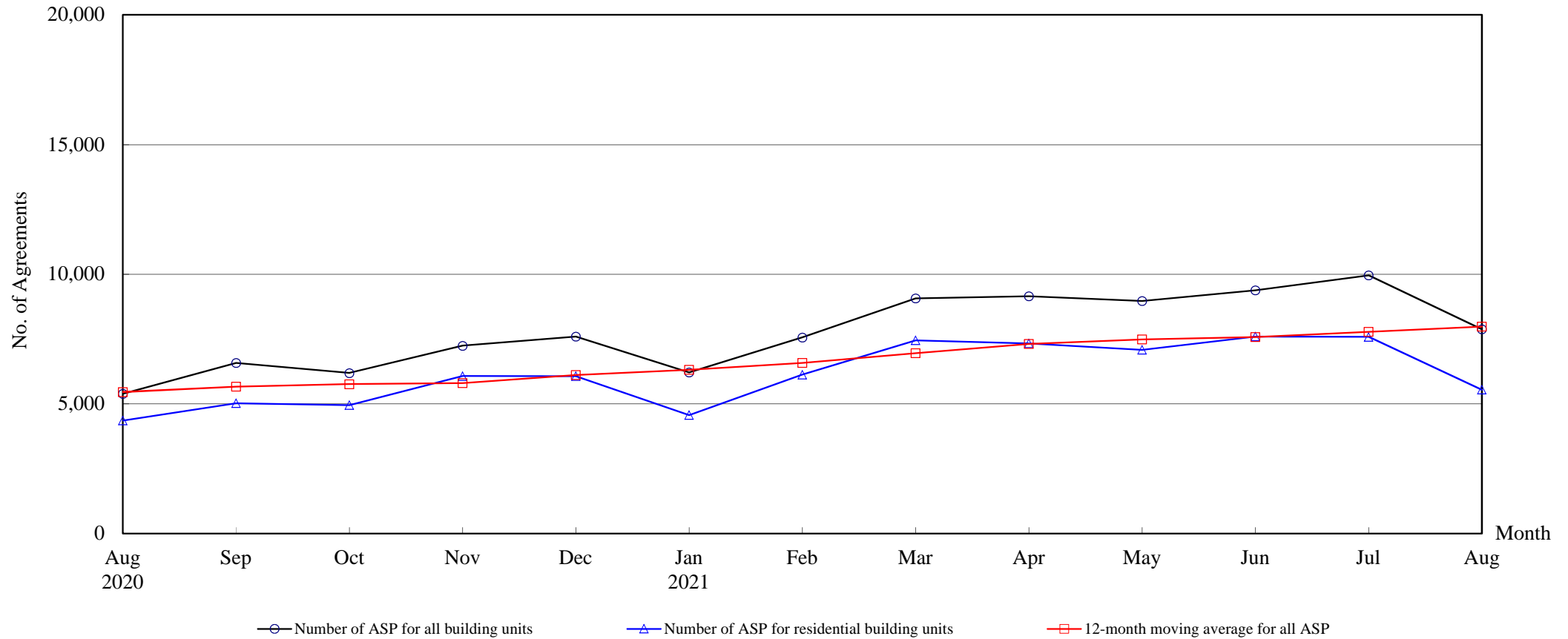

building units from August 2020 to August 2021



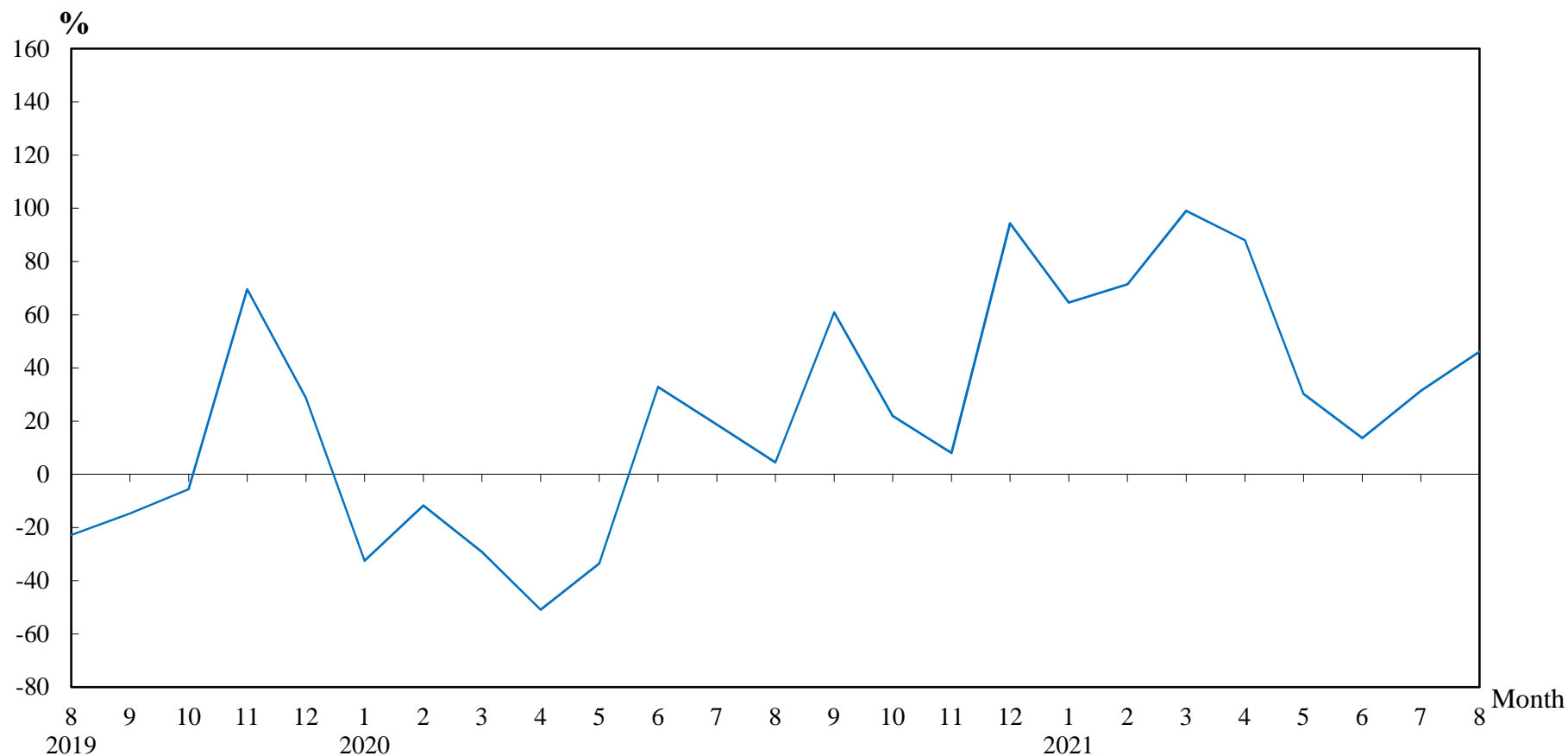
