**Details of Compulsory Testing Notice**

1. Any person who had been present at Valiant Park, 52 Conduit Road, Mid-levels, Hong Kong for more than two hours at any time during the period from August 13 to September 4, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by September 6, 2021. If persons subject to compulsory testing have previously undergone testing between September 2 and September 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Block 6, Peak One, 63 Mei Tin Road, Tai Wai, Sha Tin, New Territories, Hong Kong for more than two hours at any time during the period from August 13 to September 4, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by September 6, 2021. If persons subject to compulsory testing have previously undergone testing between September 2 and September 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Eco-Energy Trading Limited, Flat 1, 2/F, Casey Building, 38 Lok Ku Road, Sheung Wan, Hong Kong for more than one hour at any time during the period from August 13 to August 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 6, 2021. If persons subject to compulsory testing have previously undergone testing between September 2 and September 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Tai Hing, Unit A, G/F & Cockloft, Sui Fung Mansion, 12-14 Tai Wai Road & 1-15 Chik Shun Street, Tai Wai, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 2:00 p.m. on August 13, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 6, 2021. If persons subject to compulsory testing have previously undergone testing between September 2 and September 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Wolfgang's Steakhouse Hong Kong, 1/F, Printing House, 6 Duddell Street, Central, Hong Kong at any time during the period from from 7:00 p.m. on August 18 to 0:00 a.m. on August 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 6, 2021. If persons subject to compulsory testing have previously undergone testing between September 2 and September

4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at QB House, Shop 6, G/F, FWD Financial Centre, 308-320 Des Voeux Road Central, Sheung Wan, Hong Kong at any time during the period from from 2:00 p.m. to 6:00 p.m. on August 13, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 6, 2021. If persons subject to compulsory testing have previously undergone testing between September 2 and September 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Wellent System Consultants Limited, G/F, Hing Lung Commercial Building, 72 Bonham Strand, Sheung Wan, Hong Kong at any time during the period from from 2:00 p.m. to 6:00 p.m. on August 13, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 6, 2021. If persons subject to compulsory testing have previously undergone testing between September 2 and September 4, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
