**Details of Compulsory Testing Notice**

1. Any person who had been present at 74 Tai Tei Tong, Mui Wo, Lantau Island, New Territories, Hong Kong for more than two hours at any time during the period from August 14 to September 4, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Dim Dim Sum, G/F, 104-106 Tung Choi Street, Mong Kok, Kowloon, Hong Kong at any time during the period from 6:00 p.m. to 11:00 p.m. on August 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at MacPherson Stadium, 1/F, 38 Nelson Street, Mong Kok, Kowloon, Hong Kong at any time during the period from 5:00 p.m. to 7:00 p.m. on August 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at Simplylife, Shop 129, Level 1, New Town Plaza (Phase 1), Sha Tin, New Territories, Hong Kong at any time during the period from 1:00 p.m. to 6:00 p.m. on August 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at The Coffee Academics, 24 D'Aguilar Street, Central, Hong Kong at any time during the period from 11:00 a.m. to 2:00 p.m. on August 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have

complied with the requirements set out in the compulsory testing notice.

6. Any person who had been present at Bank of China (Hong Kong), G/F, South China Building, 1-3 Wyndham Street, Central, Hong Kong at any time during the period from 11:00 a.m. to 12:00 noon on August 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
7. Any person who had been present at China Bear, G/F, Mui Wo Centre, 3 Ngan Wan Road, Mui Wo, Lantau Island, New Territories, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on August 26, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
8. Any person who had been present at Roman Restaurant, Block A, G/F, Grandview Mansion, 11 Mui Wo Ferry Pier Road, Mui Wo, Lantau Island, New Territories, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on August 17 or 1:00 p.m. to 6:00 p.m. on August 26, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
9. Any person who had been present at Simplylife, Shop B05-06, 1/F, Queensway Plaza, 93 Queensway, Admiralty, Hong Kong at any time during the period from 11:00 a.m. to 4:00 p.m. on August 22, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
10. Any person who had been present at Dancing Kettle Coffee Bar, Shop 59, G/F, Shopping Arcade, Manor Centre, 213 Un Chau Street & 218 Fuk Wing Street, Sham Shui Po, Kowloon, Hong Kong at any time during the period from 4:00 p.m. to 9:00 p.m. on August 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be

taken to have complied with the requirements set out in the compulsory testing notice.

11. Any person who had been present at Yu Mai, Shop L2-146, 2/F, V Walk, 28 Sham Mong Road, Sham Shui Po, Kowloon, Hong Kong at any time during the period from 1:00 p.m. to 5:00 p.m. on August 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
12. Any person who had been present at Habitu Caffe, Shop 1075, Level 1, Yoho Mall I, GRAND YOHO, 9 Long Yat Road, Yuen Long, New Territories, Hong Kong at any time during the period from 6:00 p.m. to 11:00 p.m. on August 15, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
13. Any person who had been present at BUGIS, Shop LG15-16, LG1/F, Tin Yiu Plaza, Tin Yiu Estate, 2 Tin Wu Road, Tin Shui Wai, New Territories, Hong Kong at any time during the period from 4:00 p.m. to 7:00 p.m. on August 15, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
14. Any person who had been present at Fan Straight Lane, Shop H, G/F, Mariana Building, 96-104 Kin Yip Street & 53-59 Yau San Street, Yuen Long, New Territories, Hong Kong at any time during the period from 10:00 p.m. on August 14 to 3:00 a.m. on August 15, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
15. Any person who had been present at 十八座狗仔粉, Shop 3, G/F, Block D-F, Hing Nin Building, 59 Kin Yip Street, Yuen Long, New Territories, Hong Kong at any time during the period from 9:00 p.m. to 11:00 p.m. on August 14, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September

5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Hong Kong Wetland Park, Wetland Park Road, Tin Shui Wai, New Territories, Hong Kong at any time during the period from 2:00 p.m. to 7:00 p.m. on August 14, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
17. Any person who had been present at Yagami, Shop 1, G/F, One Sky Mall, 8 Tin Sau Road, Tin Shui Wai, New Territories, Hong Kong at any time during the period from 1:00 p.m. to 3:00 p.m. on August 14, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
18. Any person who had been present at Harbour Plaza Resort City Hong Kong Tower 1, 12 Tin Yan Road, Tin Shui Wai, New Territories, Hong Kong at any time during the period from August 14 to August 15, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 7, 2021. If persons subject to compulsory testing have previously undergone testing between September 3 and September 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
