## 6 September 2021 Details of Compulsory Testing Notice

## A. Places visited by a preliminary positive case involving L452R mutant strain

- 1. Any person who had been present at Jewelio Design Limited, Unit 07, 8/F, Block A, Focal Industrial Centre, 21 Man Lok Street, Hung Hom, Kowloon, Hong Kong for more than one hour at any time during the period from August 15 to August 20, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Plaza Premium Lounge (Near Gate 1, Departure Hall), Level 6, Terminal 1, Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 8:00 a.m. to 10:00 a.m. on August 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at Pho Le, Shop No. L4-19, Level 4, APM, Phase 5 Millennium City, 418 Kwun Tong Road, Kwun Tong, Kowloon, Hong Kong at any time during the period from 3:00 p.m. to 6:00 p.m. on August 23, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 4. Any person who had been present at Romantic Hotel, 9 Norfolk Road, Kowloon Tong, Kowloon, Hong Kong at any time during the period from 3:00 p.m. to 6:00 p.m. on August 22, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 5. Any person who had been present at Festival Walk, 80 Tat Chee Avenue, Kowloon Tong, Kowloon, Hong Kong at any time during the period from

- 4:00 p.m. to 8:00 p.m. on August 22, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 6. Any person who had been present at Chan Kan Kee Chiu Chow Restaurant 1948, Shop Unit 353B, Level 3, The LOHAS, 1 Lohas Park Road, Tseung Kwan O, New Territories, Hong Kong at any time during the period from 7:00 p.m. to 10:00 p.m. on 21 August, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 7. Any person who had taken any of New World First Buses running on route number 796X from Tseung Kwan O Industrial Estate to Tsim Sha Tsui East at any time during the period from 7:00 a.m. to 10:00 a.m. from August 18 to August 20, 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 8. Any person who had taken any of New World First Buses running on route number 796X from Tsim Sha Tsui East to Tseung Kwan O Industrial Estate at any time during the period from 6:00 p.m. to 9:00 p.m. from August 18 to August 20, 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 9. Any person who had been present at Thai Food Fusion, Shop 9-11, 1/F, Sing Win Factory Building, 15-17 Shing Yip Street, Kwun Tong, Kowloon, Hong Kong at any time during the period from 3:00 p.m. to 6:00 p.m. on August 17, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 10. Any person who had been present at Viva Villa, 1 Rutland Quadrant, Kowloon Tong, Kowloon, Hong Kong at any time during the period from 11:00 a.m. to

- 2:00 p.m. on August 17, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 11. Any person who had been present at Cozy Coffee, G/F&1/F, 72&74 Po Tung Road, Sai Kung, New Territories, Hong Kong at any time during the period from 10:00 a.m. to 12:00 noon on August 17, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 12. Any person who had been present at Teawood Taiwanese Café & Restaurant, Shop No. L4-19, Level 4, APM, Phase 5 Millennium City, 418 Kwun Tong Road, Kwun Tong, Kowloon, Hong Kong at any time during the period from 7:00 p.m. to 10:00 p.m. on August 16, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 13. Any person who had been present at Praise House Congee & Noodle Cuisine, Shop Unit 203, Level 2, The LOHAS, 1 Lohas Park Road, Tseung Kwan O, New Territories, Hong Kong at any time during the period from 11:00 a.m. to 2:00 p.m. on August 16, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 14. Any person who had been present at King's Delicacy, Shop Unit 333, Level 3, The LOHAS, 1 Lohas Park Road, Tseung Kwan O, New Territories, Hong Kong at any time during the period from 8:00 p.m. to 11:00 p.m. on August 15, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## B. Specified premises under additional testing

1. Any person who had been present at Hong Kong Football Club - Coffee Shop,

- 2/F, Hong Kong Football Club, 3 Sports Road, Happy Valley, Hong Kong at any time during the period from 7:30 a.m. to 11:30 a.m. on August 27, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Pinnacle Performance, 7th Floor, Morrison Plaza, 9 Morrison Hill Road, Wan Chai, Hong Kong at any time during the period from 6:00 a.m. to 8:00 a.m. on August 27, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## C. Others

(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notices)

- 1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from August 24 to September 6, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by September 8, 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by September 10, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before August 25, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before August 25, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before August 25, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published Government's COVID-19 thematic website (www.coronavirus.gov.hk/pdf/list of recognised covid19 vaccines.pdf).

- 2. Students of S.K.H. Kei Fook Primary School, 555 Cheung Sha Wan Road, Sham Shui Po, Kowloon, Hong Kong at Primary 4 and teachers (including but not limited to full-time, part-time and relief teachers) of the specified schools who had face-to-face lessons with such students at the specified level during the period from August 24 to September 6, 2021 have to undergo testing by September 8, 2021. If persons subject to compulsory testing have previously undergone testing between September 4 and September 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
