Details of Compulsory Testing Notice

A. Specified premises under additional testing

1. Any person who had been present at Dim Dim Sum, G/F, 104-106 Tung Choi Street, Mong Kok, Kowloon, Hong Kong at any time during the period from 6:00 p.m. to 11:00 p.m. on August 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 17, 2021. If persons subject to compulsory testing have previously undergone testing between September 13 and September 15, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at MacPherson Stadium, 1/F, 38 Nelson Street, Mong Kok, Kowloon, Hong Kong at any time during the period from 5:00 p.m. to 7:00 p.m. on August 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 17, 2021. If persons subject to compulsory testing have previously undergone testing between September 13 and September 15, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Simplylife, Shop 129, Level 1, New Town Plaza (Phase 1), Sha Tin, New Territories, Hong Kong at any time during the period from 1:00 p.m. to 6:00 p.m. on August 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 17, 2021. If persons subject to compulsory testing have previously undergone testing between September 13 and September 15, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at The Coffee Academics, 24 D'Aguilar Street, Central, Hong Kong at any time during the period from 11:00 a.m. to 2:00 p.m. on August 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 17, 2021. If persons subject to compulsory testing have previously undergone testing between September 13 and September 15, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Bank of China (Hong Kong), G/F, South China Building, 1-3 Wyndham Street, Central, Hong Kong at any time during the period from 11:00 a.m. to 12:00 noon on August 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo

testing by September 17, 2021. If persons subject to compulsory testing have previously undergone testing between September 13 and September 15, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Others

(Persons who have completed a COVID-19 vaccination course¹ would be taken to have complied with the requirements set out in the compulsory testing notices)

1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from September 2 to September 15, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by September 17, 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by September 19, 2021. If persons subject to compulsory testing have previously undergone testing between September 13 and September 15, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

- (6) Hong Kong Christian Service Morrison Hill Child Development Centre, 1/F, Tang Shiu Kin Hospital Community Ambulatory Care Centre, 282 Queen's Road East, Wan Chai, Hong Kong

¹ If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before September 3, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before September 3, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before September 3, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website (www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf).
