Details of Compulsory Testing Notice

A. Places visited by an imported case involving L452R mutant strain

- 1. Any person who had been present at Aigburth, 12 Tregunter Path, Mid-Levels, Hong Kong for more than two hours at any time during the period from August 25 to September 17, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by September 19, 2021. If persons subject to compulsory testing have previously undergone testing between September 15 and September 17, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Schindler Management Asia-Pacific, Unit 1506A, Level 15, International Commerce Centre, 1 Austin Road West, Yau Tsim Mong, Kowloon, Hong Kong for more than one hour at any time during the period from August 25 to August 31, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 19, 2021. If persons subject to compulsory testing have previously undergone testing between September 15 and September 17, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at Obihiro Hageten, Shop 2103-05, 2/F, Elements, 1 Austin Road West, Tsim Sha Tsui, Kowloon, Hong Kong at any time during the period from 11:00 a.m. to 4:00 p.m. on August 27, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 19, 2021. If persons subject to compulsory testing have previously undergone testing between September 15 and September 17, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Places visited by the non-locally confirmed case

- 1. Any person who had been present at 7 Lyttelton Road, Mid-Levels, Hong Kong for more than two hours at any time during the period from August 8 to September 17, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by September 19, 2021. If persons subject to compulsory testing have previously undergone testing between September 15 and September 17, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at BTIG Hong Kong Limited, 18/F, Kinwick Centre, 32 Hollywood Road, Central, Hong Kong for more than one hour at any time during the period from August 8 to August 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 19, 2021. If persons subject to compulsory testing have previously undergone testing between September 15 and September 17, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at The American Club, 28 Tai Tam Road, Tai Tam, Hong Kong at any time during the period from 8:00 a.m. to 1:00 p.m. on August 14, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 19, 2021. If persons subject to compulsory testing have previously undergone testing between September 15 and September 17, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 4. Any person who had been present at Brass Spoon, Shop B, G/F, 1-3 Moon Street, Wan Chai, Hong Kong at any time during the period from 2:00 p.m. to 7:00 p.m. on August 14, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 19, 2021. If persons subject to compulsory testing have previously undergone testing between September 15 and September 17, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 5. Any person who had been present at Wolfgang Puck Kitchen, Shop 5T150, Level 5, Terminal 1, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 3:00 p.m. to 8:00 p.m. on August 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by September 19, 2021. If persons subject to compulsory testing have

previously undergone testing between September 15 and September 17, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

C. Others

(Persons who have completed a COVID-19 vaccination course¹ would be taken to have complied with the requirements set out in the compulsory testing notices)

- 1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from September 4 to September 17, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by September 19, 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by September 21, 2021. If persons subject to compulsory testing have previously undergone testing between September 15 and September 17, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before September 5, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before September 5, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before September 5, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this COVID-19 thematic purpose published on the Government's website (www.coronavirus.gov.hk/pdf/list of recognised covid19 vaccines.pdf).

If persons subject to compulsory testing have previously undergone testing between September 15 and September 17, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
