Details of Compulsory Testing Notice

A. Places visited by the preliminary positive imported cases who had stayed in Hong Kong during the incubation period

1. Any person who had been present at Jones Hive, 8 Jones Street, Causeway Bay, Hong Kong for more than two hours at any time during the period from 5 September to 27 September 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Block C, Hankow Centre, Tsim Sha Tsui, Kowloon, Hong Kong for more than two hours at any time during the period from 5 September to 27 September 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Goldman Sachs (Asia) LLC, 23/F, Lee Garden Three, 1 Sunning Road, Causeway Bay, Hong Kong for more than one hour at any time during the period from 5 September to 10 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at Royal Forex Limited, Shop 9, G/F, CFC Tower, 22-28 Mody Road, Tsim Sha Tsui, Kowloon, Hong Kong for more than one hour at any time during the period from 5 September to 10 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Crystal Jade La Mian Xiao Long Bao, Shop 2018-2020, 2/F, IFC, 1 Harbour View Street, Central, Hong Kong at any time during the period from 12:00 p.m. to 6:00 p.m. on 5 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

6. Any person who had been present at Sushiro, Shop 201, 2/F, Infinitus Plaza, 199 Des Voeux Road Central, Sheung Wan, Hong Kong at any time during the period from 5:00 p.m. to 11:00 p.m. on 7 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
7. Any person who had been present at Forecourt Zone B, Happy Valley Racecourse, Happy Valley, Hong Kong in any capacity at any time during the period from 5:00 p.m. to 12:00 midnight on 8 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
8. Any person who had been present at Public Takeaway Counter (1A), 1/F, Grandstand, Happy Valley Racecourse, Happy Valley, Hong Kong at any time during the period from 5:00 p.m. to 12:00 midnight on 8 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
9. Any person who had been present at Forecourt Takeaway Counter (GC), Forecourt (Beer Garden), Happy Valley Racecourse, Happy Valley, Hong Kong at any time during the period from 5:00 p.m. to 12:00 midnight on 8 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
10. Any person who had been present at TIRPSE, Shop 219, 2/F, K11 Musea, Victoria Dockside, 18 Salisbury Road, Tsim Sha Tsui, Kowloon, Hong Kong at any time during the period from 6:00 p.m. to 11:00 p.m. on 9 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
11. Any person who had been present at Fung Shing Restaurant, G/F & M/F, 28-30 Leighton Road, Causeway Bay, Hong Kong at any time during the period from 9:00 a.m. to 3:00 p.m. on 10 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would

be taken to have complied with the requirements set out in the compulsory testing notice.

12. Any person who had been present at The Wing, First, Level 7, Terminal 1 near gates 1 to 4, Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 4:00 p.m. to 10:00 p.m. on 11 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
13. Any person who had been present at St Andrew's Church, 138 Nathan Road, Tsim Sha Tsui, Kowloon, Hong Kong at any time during the period from 11:00 a.m. to 2:00 p.m. on 5 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Others

(Persons who have completed a COVID-19 vaccination course¹ would be taken to have complied with the requirements set out in the compulsory testing notices)

1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from 14 September to 27 September 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by 29 September 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by 1 October 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September 2021, they would be taken to have complied

¹ If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before 15 September, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before 15 September, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before 15 September, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website (www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf).

29 September 2021. If persons subject to compulsory testing have previously undergone testing between 25 September and 27 September 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
