## **30 September 2021 Details of Compulsory Testing Notice**

## A. Places visited by the non-locally confirmed cases

- 1. Any person who had been present at Block 7, Phase 2, Belvedere Garden, Tsuen Wan, New Territories, Hong Kong for more than two hours at any time during the period from 5 September to 30 September 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 2 October 2021. If persons subject to compulsory testing have previously undergone testing between 28 September and 30 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at HKAYP Jockey Club Duke of Edinburgh Training Camp, 90 Hang Ha Po, Lam Tsuen, Tai Po, New Territories, Hong Kong for more than two hours at any time during the period from 14 September to 30 September 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 2 October 2021. If persons subject to compulsory testing have previously undergone testing between 28 September and 30 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at Tower 3, Monterey Cove, Phase 1, Caribbean Coast, 2 Kin Tung Road, Tung Chung, Lantau Island, New Territories, Hong Kong for more than two hours at any time during the period from 7 September to 30 September 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 2 October 2021. If persons subject to compulsory testing have previously undergone testing between 28 September and 30 September, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## **B.** Others

(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be

If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before 18 September, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before 18 September, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before 18 September, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website

taken to have complied with the requirements set out in the compulsory testing notices)

- 1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from 17 September to 30 September 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by 2 October 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by 4 October 2021. If persons subject to compulsory testing have previously undergone testing between 28 September and 30 September 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
  - (1) St Vincent De Paul Nursery School, 2/F, Bo Fung Building, 5 Horse Shoe Lane, Kwun Tong, Kowloon, Hong Kong
  - (2) YMCA of Hong Kong Christian Nursery School (Farm Road), Portion of G/F, Majestic Park, 11 Farm Road, Kowloon City, Kowloon, Hong Kong
- 2. Students of the schools at the levels specified below and teachers (including but not limited to full-time, part-time and relief teachers) of the specified schools who had face-to-face lessons with such students at the specified levels during the period from 17 September to 30 September have to undergo testing by 2 October 2021. If persons subject to compulsory testing have previously undergone testing between 28 September and 30 September 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
  - Primary 1 of Bishop Ford Memorial School, 20 Pui Man Street, Tung Tau Tsuen, Kowloon, Hong Kong
  - (2) Primary 1 of Kowloon City Baptist Church Hay Nien Primary School, Chevalier Garden, 3 Hang Shun Street, Ma On Shan, New Territories, Hong Kong
