12 October 2021 Details of Compulsory Testing Notice

A. Places visited by the non-locally confirmed case

- 1. Any person who had been present at Block 7, King's Park Villa, Ho Man Tin, Kowloon, Hong Kong for more than two hours at any time during the period from 12 September to 12 October 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 14 October 2021. If persons subject to compulsory testing have previously undergone testing between 10 October and 12 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Parkside Chambers, Room 3101, 31/F, Two Pacific Place, 88 Queensway, Admiralty, Hong Kong for more than one hour at any time during the period from 12 September to 24 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 14 October 2021. If persons subject to compulsory testing have previously undergone testing between 10 October and 12 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Others

(Persons who have completed a COVID-19 vaccination course¹ would be taken to have complied with the requirements set out in the compulsory testing notices) Students of the schools at the levels specified below and teachers (including but not limited to full-time, part-time and relief teachers) of the specified schools who had face-to-face lessons with such students at the specified levels during the period from 29 September to 12 October 2021 have to undergo testing by 14 October 2021. If persons subject to compulsory testing have previously undergone testing between 10 October and 12 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

- (1) Primary 1 of A.D. & F.D. of Pok Oi Hospital Mrs Cheng Yam On School, 3 Tuen Lee Street, Tuen Mun, New Territories, Hong Kong
- (2) All levels of Haven of Hope Sunnyside School, 301 Anderson Road, Tseung Kwan O, New Territories, Hong Kong

If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before 30 September, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before 30 September, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before 30 September, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this published the Government's COVID-19 on thematic website (www.coronavirus.gov.hk/pdf/list of recognised covid19 vaccines.pdf).
