Details of Compulsory Testing Notice**A. Places visited by the preliminary positive imported case who had stayed in Hong Kong during the incubation period**

1. Any person who had been present at Tower 10, Phase 3 - The Graces, Providence Bay, 9 Fo Chun Road, Tai Po, New Territories, Hong Kong for more than two hours at any time during the period from 17 September to 13 October 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 16 October 2021. If persons subject to compulsory testing have previously undergone testing between 11 October and 13 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Dr. Liu Kai Ling Clinic, Shop 307, 3/F, On Wo House, Tai Wo Estate, Tai Po, New Territories, Hong Kong at any time during the period from 3:30 p.m. to 6:30 p.m. on 8 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 16 October 2021. If persons subject to compulsory testing have previously undergone testing between 11 October and 13 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Market Place By Jasons, Shop 16, LG/F, Mayfair Lane, 21 Fo Chun Road, Tai Po, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on 11 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 16 October 2021. If persons subject to compulsory testing have previously undergone testing between 11 October and 13 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Others

(Persons who have completed a COVID-19 vaccination course¹ would be taken to

¹ If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before 1 October, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before 1 October, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before 1 October, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website (www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf).

have complied with the requirements set out in the compulsory testing notices)

1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from 30 September to 13 October 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by 16 October 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by 18 October 2021. If persons subject to compulsory testing have previously undergone testing between 11 October and 13 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
 - (1) Hong Chi Association Hong Chi Pinehill Pre-School Centre (Residential), Pinehill Village, Chung Nga Road, Nam Hang, Tai Po, New Territories, Hong Kong
2. Students of the schools at the levels specified below and teachers (including but not limited to full-time, part-time and relief teachers) of the specified schools who had face-to-face lessons with such students at the specified levels during the period from 30 September to 13 October 2021 have to undergo testing by 16 October 2021. If persons subject to compulsory testing have previously undergone testing between 11 October and 13 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
 - (1) Primary 1 of Po Leung Kuk Fong Wong Kam Chuen Primary School, Leung King Estate, Tuen Mun, New Territories, Hong Kong
 - (2) Primary 1 of Fung Kai No.1 Primary School, 15 & 19 Jockey Club Road, Sheung Shui, New Territories, Hong Kong
