**Details of Compulsory Testing Notice**

**A. Specified premises under additional testing**

1. Any person who had been present at Room RJ0M2, Mezzanine Floor, Main Building, SuperTerminal 1, 9 Chun Wan Road, Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 30 September to 14 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 17 October 2021.
2. Any person who had been present at HACTL, SuperTerminal 1, 9 Chun Wan Road, Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong for more than 1 hour at any time during the period from 15 September to 19 September or from 21 September to 7 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 17 October 2021. If persons subject to compulsory testing have previously undergone testing between 13 October and 15 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Thai Fung Mei, Unit B, G/F, Good Year Industrial Building, 119-121 How Ming Street, Kwun Tong, Kowloon, Hong Kong at any time during the period from 2:30 p.m. to 5:00 p.m. on 19 September 2021 or from 2:30 p.m. to 5:00 p.m. on 26 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 17 October 2021. If persons subject to compulsory testing have previously undergone testing between 13 October and 15 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at Gusto, Shop R11 & R12, G/F, Wo Che Plaza, 3 Tak Hau Street, Sha Tin, New Territories, Hong Kong at any time during the period from 8:30 a.m. to 11:00 a.m. on 29 September 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 17 October 2021. If persons subject to compulsory testing have previously undergone testing between 13 October and 15 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Salala, Shop L101, 1/F, Sun Chui Shopping Centre, Sha Tin, New Territories, Hong Kong at any time during the period from 8:00 a.m. to 2:00 p.m. from 15 September to 18 September 2021, from 8:00 a.m. to 2:00 p.m. on 20 September 2021, from 8:00 a.m. to 2:00 p.m. on 21 September 2021, from 8:00 a.m. to 2:00 p.m. on 23 September 2021, from 8:00 a.m. to 2:00 p.m. from 26 September to 1 October 2021 or from 8:00 a.m. to 2:00 p.m. on 6 October 2021 (including but not limited to full-time, part-

time and relief staff and visitors), has to undergo testing by 17 October 2021. If persons subject to compulsory testing have previously undergone testing between 13 October and 15 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

6. Any person who had been present at Tung Wah Group of Hospitals Chan King Har Kindergarten, G/F, Sun Yuet House, Sun Chui Estate, Sha Tin, New Territories, Hong Kong at any time during the period from 11:00 a.m. to 1:00 p.m. from 21 September to 24 September 2021, from 11:00 a.m. to 1:00 p.m. from 27 September to 30 September 2021 or from 11:00 a.m. to 1:00 p.m. from 4 October to 6 October 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by 17 October 2021. If persons subject to compulsory testing have previously undergone testing between 13 October and 15 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
7. Any person who had been present at Wellcome Superstore, Shop 215, 2/F, Lung Hang Commercial Centre, Sha Tin, New Territories, Hong Kong at any time during the period from 10 a.m. to 11 a.m. or from 4:00 p.m. to 5:00 p.m. on 6 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 17 October 2021. If persons subject to compulsory testing have previously undergone testing between 13 October and 15 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
8. Any person who had been present at PARKnSHOP, Shop L001, G/F, Sun Chui Market, 2 Chui Tin Street, Sha Tin, New Territories, Hong Kong at any time during the period from 3:00 p.m. to 5:00 p.m. on 6 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 17 October 2021. If persons subject to compulsory testing have previously undergone testing between 13 October and 15 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
9. Any person who had taken any of buses running on route number E42 from Sha Tin (Pok Hong) to Airport (Ground Transportation Centre) at any time during the period from 5:00 p.m. to 10:00 p.m. on any day of 15 September to 19 September or 21 September to 6 October 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 17 October 2021. If persons subject to compulsory testing have previously undergone testing between 13 October and 15 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
10. Any person who had taken any of buses running on route number E42 from Airport (Ground Transportation Centre) to Sha Tin (Pok Hong) at any time during the period from 6:00 a.m. to 12:00 noon on any day of 16 September to 20 September or 22 September to 6 October 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 17 October 2021. If persons subject to compulsory testing have previously undergone testing between 13 October and 15 October 2021, they would be

taken to have complied with the requirements set out in the compulsory testing notice.

## **B. Others**

*(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notices)*

1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from 2 October to 15 October 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by 17 October 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by 19 October 2021. If persons subject to compulsory testing have previously undergone testing between 13 October and 15 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
  - (1) The Church of Christ in China Fuk Yau No. 2 Kindergarten/Fuk Yau No.2 Child Care Centre Cum Day Creche, G/F, Shek Lin House, Shek Wai Kok Estate, Tsuen Wan, New Territories, Hong Kong
  - (2) Chi Yun School, 13 Chi Kiang Street, To Kwa Wan, Kowloon, Hong Kong
2. Any person who had been present at Haven of Hope Sunnyside School, 301 Anderson Road, Tseung Kwan O, New Territories, Hong Kong for more than two hours at any time during the period from 29 September to 12 October 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by 17 October 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by 19 October 2021. If persons subject to compulsory testing have previously undergone testing between 10 October and 15 October 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

<sup>1</sup> If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before 3 October, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before 3 October, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before 3 October, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website ([www.coronavirus.gov.hk/pdf/list\\_of\\_recognised\\_covid19\\_vaccines.pdf](http://www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf)).
