Details of Compulsory Testing Notice

(*Persons who have completed a COVID-19 vaccination course¹ would be taken to have complied with the requirements set out in the compulsory testing notices*)

- 1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from 22 October to 4 November 2021 (including but not limited to full-time, part-time and relief staff, students and visitors) has to undergo testing by 6 November 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by 8 November 2021. If persons subject to compulsory testing have previously undergone testing between 2 November and 4 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
 - (1) Yan Chai Hospital Nina Lam Kindergarten/Child Care Centre, G/F, 6 Tin Ho Road, Tin Shui Wai, New Territories, Hong Kong
 - (2) Yan Chai Hospital Zonta Club of Kowloon Kindergarten/Child Care Centre, Wing B & Part of Wing A, G/F, Hang Yip House, Cheung Hang Estate, Tsing Yi, New Territories, Hong Kong
 - (3) Hong Kong Society for the Protection of Children Thomas Tam Nursery School, King George V Memorial Park, Hospital Road, Sai Ying Pun, Hong Kong
 - (4) Heng On Baptist Nursery School, Unit 1-5, G/F, Heng Sing House, Heng On Estate, Ma On Shan, New Territories, Hong Kong

If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before 23 October 2021, except for persons previously infected with COVID-19 who are to receive one dose of vaccine at least 14 days ago, i.e. having received the first dose of COVID-19 vaccine on or before 23 October 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before 23 October 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for specified purposes as published on the Government's COVID-19 thematic website (https://www.coronavirus.gov.hk/pdf/list_of_recognised_c ovid19_vaccines.pdf).
