Any person who had been present at Block 5, Rambler Crest, 1 Tsing Yi Road, Tsing Yi, New Territories, Hong Kong for more than 2 hours at any time during the period from 23 October 2021 to 14 November 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 16 November 2021. If persons subject to compulsory testing have previously undergone testing between 12 November and 14 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Market Place by Jasons, Shop G1 & G10, G/F, Olympian City 2, 18 Hoi Ting Road, Tai Kok Tsui, Kowloon, Hong Kong at any time during the period from 12:00 noon to 4:00 p.m. on 9 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 16 November 2021. If persons subject to compulsory testing have previously undergone testing between 12 November and 14 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Central Pier No. 6, Man Kwong Street, Central, Hong Kong at any time during the period from 7:00 p.m. to 10:00 p.m. on 26 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 16 November 2021. If persons subject to compulsory testing have previously undergone testing between 12 November and 14 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Mui Wo Ferry Pier, Mui Wo Ferry Pier Road, Mui Wo, Lantau Island, New Territories, Hong Kong at any time during the period from 7:00 p.m. to 10:00 p.m. on 26 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 16 November 2021. If persons subject to compulsory testing have previously undergone testing between 12 November and 14 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Learning Habitat Kindergarten (Hampton Loft), Shop 2, 5/F, Hampton Loft, 11 Hoi Fan Road, Tai Kok Tsui, Kowloon, Hong Kong for more than 2 hours at any time during the period from 22 October to 13 November 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by 16 November 2021.
