Details of Compulsory Testing Notice

A. Places visited by the preliminary positive imported cases who had stayed in Hong Kong during the incubation period

1. Any person who had been present at Block 4, New Jade Garden, 233 Chai Wan Road, Chai Wan, Hong Kong for more than 2 hours at any time during the period from 25 October to 16 November 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Tower 3, Ocean Court, 3 Aberdeen Praya Road, Aberdeen, Hong Kong for more than 2 hours at any time during the period from 26 October to 16 November 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Hong Kong Disneyland Park, Hong Kong Disneyland Resort, Lantau Island, New Territories, Hong Kong at any time during the period from 11:00 a.m. to 6:00 p.m. on 14 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at Tao Heung, Shop 204, 2/F, Paradise Mall, 100 Shing Tai Road, Chai Wan, Hong Kong at any time during the period from 10:00 a.m. to 3:00 p.m. on 13 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Chai Wan Market, G/F & 1/F, Chai Wan Municipal Services Building, 338 Chai Wan Road, Chai Wan, Hong Kong at any time during the period from 8:00 a.m. to 10:00 a.m. on 8 November 2021, 8:00 a.m. to 10:00 a.m. on 9 November 2021, 8:00 a.m. to 10:00 a.m. on 10 November 2021, 8:00 a.m. to 10:00 a.m. on 11 November 2021 or 8:00 a.m. to 10:00 a.m. on 12 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing

between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

6. Any person who had been present at Yue Wan Market, G/F, 33 Yee Fung Street, Chai Wan, Hong Kong at any time during the period from 8:00 a.m. to 10:00 a.m. on 8 November 2021, 8:00 a.m. to 10:00 a.m. on 9 November 2021, 8:00 a.m. to 10:00 a.m. on 10 November 2021, 8:00 a.m. to 10:00 a.m. on 11 November 2021 or 8:00 a.m. to 10:00 a.m. on 12 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
7. Any person who had been present at Immigration Department, 8/F, Immigration Tower, 7 Gloucester Road, Wan Chai, Hong Kong at any time during the period from 1:00 p.m. to 4:00 p.m. on 5 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
8. Any person who had been present at South-East Med. Lab. Holdings Ltd., Flat B, 5/F, Success Commercial Building, 245-251 Hennessy Road, Wan Chai, Hong Kong at any time during the period from 11:00 a.m. to 1:00 p.m. on 5 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
9. Any person who had been present at Asean Employment Centre, Room 112-113, 1/F, Empire Court, 2-4 Hysan Avenue, Causeway Bay, Hong Kong at any time during the period from 12:00 noon to 3:00 p.m. on 5 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
10. Any person who had been present at Chiu Yuen Restaurant, G/F, 7 Tung Sing Road, Aberdeen, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on 16 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
11. Any person who had been present at Royal Legend, 1/F, Golden Court, 22-52 Electric Road, Tin Hau, Hong Kong at any time during the period from 6:00 p.m. to 11:00 p.m. on 15 November 2021 (including but not limited to full-time,

part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

12. Any person who had been present at Dragon Place, 1/F, Site 3, Aberdeen Centre, 1-5 Nam Ning Street, Aberdeen, Hong Kong at any time during the period from 8:00 a.m. to 11:00 a.m. on 15 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
13. Any person who had been present at Trusty Congee King, Shop 14, 1/F, Site 4, Aberdeen Centre, 6-12 Nam Ning Street, Aberdeen, Hong Kong at any time during the period from 8:00 a.m. to 10:00 a.m. on 13 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
14. Any person who had been present at Chow Tai Fook (Jade & Pearl Plaza Branch), 24-36 Paterson Street, Causeway Bay, Hong Kong at any time during the period from 3:00 p.m. to 6:00 p.m. on 12 November 2021 or 2:00 p.m. to 4:00 p.m. on 13 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
15. Any person who had been present at Logos Book House, 15/F, Congregation House, 119 Leighton Road, Causeway Bay, Hong Kong at any time during the period from 4:00 p.m. to 6:00 p.m. on 13 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
16. Any person who had been present at Tsui Yuen Dessert, Shop A, G/F, Percival House, 83 Percival Street, Causeway Bay, Hong Kong at any time during the period from 5:00 p.m. to 6:00 p.m. on 13 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
17. Any person who had been present at Aberdeen Post Office, G/F, Kam Fung

Building, 171 Aberdeen Main Road, Aberdeen, Hong Kong at any time during the period from 10:00 a.m. to 11:00 a.m. on 12 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

18. Any person who had been present at Bowrington Road Cooked Food Centre, 1/F, Bowrington Road Market, 21 Bowrington Road, Wan Chai, Hong Kong at any time during the period from 12:00 noon to 2:00 p.m. on 12 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
19. Any person who had been present at Sanchoi Noodle, Shop 6, G/F, The Grandeur, 48 Jardine's Crescent, Causeway Bay, Hong Kong at any time during the period from 6:00 p.m. to 8:00 p.m. on 12 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
20. Any person who had been present at Royal Grand Chinese Cuisine, 2/F, Port 33, 33 Tseuk Luk Street, San Po Kong, Kowloon, Hong Kong at any time during the period from 12:00 noon to 3:00 p.m. on 11 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
21. Any person who had taken any of the buses running on route number 98 from Lei Tung Estate to Aberdeen (Chengtu Road) at any time during the period from 8:00 a.m. to 10:00 a.m. on 15 November 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
22. Any person who had taken any of the buses running on route number 38 from Chi Fu Fa Yuen to North Point Ferry Pier at any time during the period from 6:00 p.m. to 7:00 p.m. on 15 November 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

23. Any person who had taken any of the buses running on route number 38 from North Point Ferry Pier to Chi Fu Fa Yuen at any time during the period from 9:00 p.m. to 10:00 p.m. on 15 November 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
24. Any person who had taken any of the buses running on route number 72 from Causeway Bay (Moreton Terrace) to Wah Kwai Estate at any time during the period from 6:00 p.m. to 8:00 p.m. on 12 November 2021 or 6:00 p.m. to 7:00 p.m. on 13 November 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
25. Any person who had taken any of the buses running on route number 72 from Wah Kwai Estate to Causeway Bay (Moreton Terrace) at any time during the period from 11:00 a.m. to 12:00 noon on 12 November 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
26. Any person who had been present at Hsin Kuang Banquet Hall, 2/F, Site 3, Aberdeen Centre, 1-5 Nam Ning Street, Aberdeen, Hong Kong at any time during the period from 12:00 noon to 4:00 p.m. on 14 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
27. Any person who had taken any of the green minibuses running on route number 20M from Chai Wan East Industrial Area to Hing Man Estate at any time during the period from 5:00 p.m. to 6:00 p.m. on 7 November 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
28. Any person who had been present at Man Fu House, Hing Man Estate, 188 Tai Tam Road, Chai Wan, Hong Kong at any time during the period from 6:00 p.m. to 8:00 p.m. on 7 November 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14

November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

29. Any person who had been present at King Tai Court, 118 King Fuk Street, San Po Kong, Kowloon, Hong Kong at any time during the period from 2:00 p.m. to 5:00 p.m. on 11 November 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Specified premises under additional testing

1. Any person who had been present at Immigration Department, 2/F, Immigration Tower, 7 Gloucester Road, Wan Chai, Hong Kong at any time during the period from 10:00 a.m. to 3:00 p.m. on 28 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Wellcome, Basement, Empress Plaza, 17–19 Chatham Road South, Tsim Sha Tsui, Kowloon, Hong Kong at any time during the period from 1:00 p.m. to 4:00 p.m. on 29 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Marks & Spencer, Shops G3A-G3C & UG3-UG4, iSQUARE, 63 Nathan Road, Tsim Sha Tsui, Kowloon, Hong Kong at any time during the period from 1:00 p.m. to 4:00 p.m. on 29 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at Crystal Jade La Mian Xiao Long Bao, Shop 3328, 3/F, Gateway Arcade, Harbour City, 3–27 Canton Road, Tsim Sha Tsui, Kowloon, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on 6 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

C. Others

(Persons who have completed a COVID-19 vaccination course¹ would be taken to have complied with the requirements set out in the compulsory testing notices)

1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from 3 November to 16 November 2021 (including but not limited to full-time, part-time and relief staff, students and visitors) has to undergo testing by 18 November 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by 20 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
 - (1) Caritas Nursery School-Shatin, G/F, 23-25 Man Lai Road, Sha Tin, New Territories, Hong Kong
 - (2) Hong Kong Christian Service Morrison Hill Child Development Centre, 1/F Community Ambulatory Care Centre, Tang Shiu Kin Hospital, 282 Queen's Road East, Wan Chai, Hong Kong
 - (3) Caritas Nursery School-Kennedy Town, 2/F of Block A, 1/F (Portion), M1/F (Portion) & 2/F of Block B, Caritas Social Centre-Kennedy Town, 27 Pokfield Road, Kennedy Town, Hong Kong

¹ If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before 4 November, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before 4 November, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before 4 November, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website (www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf).

(4) S.K.H. St. Joseph's Church Kindergarten, 83A, Ng Ka Tsuen, Kam Sheung Road, Yuen Long, New Territories, Hong Kong

2. Students of Glenealy School, 7 Hornsey Road, Mid-Levels, Hong Kong at Primary 1 and teachers (including but not limited to full-time, part-time and relief teachers) of the specified school who had face-to-face lessons with such students at the specified level during the period from 3 November to 16 November 2021 have to undergo testing by 18 November 2021. If persons subject to compulsory testing have previously undergone testing between 14 November and 16 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
