Details of Compulsory Testing Notice

A. Places visited by the preliminary positive imported case who had stayed in Hong Kong during the incubation period

1. Any person who had been present at Yuen Fuk X-Ray Laboratory Centre, Flat F & G, 1/F, Kwan Tak Building, 19 Hong Lok Road, Yuen Long, New Territories, Hong Kong at any time during the period from 11:00 a.m. to 1:00 p.m. on 13 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 21 November 2021. If persons subject to compulsory testing have previously undergone testing between 17 November and 19 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Specified premises under additional testing

1. Any person who had been present at Gateway Hotel, Hong Kong, Harbour City, 13 Canton Road, Tsim Sha Tsui, Kowloon, Hong Kong for more than 2 hours at any time during the period from 19 October to 9 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 21 November 2021. If persons subject to compulsory testing have previously undergone testing between 17 November and 19 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Cathay Pacific City, 8 Scenic Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 21 October to 9 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 21 November 2021. If persons subject to compulsory testing have previously undergone testing between 17 November and 19 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Corner Stop Bar, G/F, 46 Hoi King Street, Tai Kok Tsui, Kowloon, Hong Kong at any time during the period from 5:00 p.m. to 7:00 p.m. on 31 October 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 21 November 2021. If persons subject to compulsory testing have previously undergone testing between 17 November and 19 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at Watami Japanese Casual Restaurant, Shop 106, Olympian City 1, 11 Hoi Fai Road, Tai Kok Tsui, Kowloon, Hong Kong at any time during the period from 6:00 p.m. to 8:00 p.m. on 31 October 2021 (including but not limited to full-time, part-time and relief staff and visitors),

has to undergo testing by 21 November 2021. If persons subject to compulsory testing have previously undergone testing between 17 November and 19 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

5. Any person who had been present at Market Place by Jasons, Shop G1 & G10, G/F, Olympian City 2, 18 Hoi Ting Road, Tai Kok Tsui, Kowloon, Hong Kong at any time during the period from 12:00 noon to 4:00 p.m. on 9 November 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 21 November 2021. If persons subject to compulsory testing have previously undergone testing between 17 November and 19 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

C. Others

(Persons who have completed a COVID-19 vaccination course¹ would be taken to have complied with the requirements set out in the compulsory testing notices)

1. Any person who had been present at Caritas Resurrection School, 31 Sui Wo Road, Sha Tin, New Territories, Hong Kong for more than two hours at any time during the period from 6 November to 19 November 2021 (including but not limited to full-time, part-time and relief staff, students and visitors) has to undergo testing by 21 November 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by 23 November 2021. If persons subject to compulsory testing have previously undergone testing between 17 November and 19 November 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

¹ If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before 7 November, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before 7 November, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before 7 November, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website (www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf).
