(4) Operating expenses include rent and rates for land and buildings, interests, agency fees, commissions and brokerage fees, repair and maintenance, fuels, electricity, freight charges and transport-related contract work, charter hire of transport equipment, communications expenses, insurance premiums, tunnel, bridge and link toll payable, vehicles parking fees, port charges as well as aircraft landing and parking expenses, etc. Provision, gain/loss on disposal of fixed assets, bad debts, penalty, write-off, donations to charities, insurance excesses as well as depreciation, amortisation and taxation payments are not included in operating expenses.
