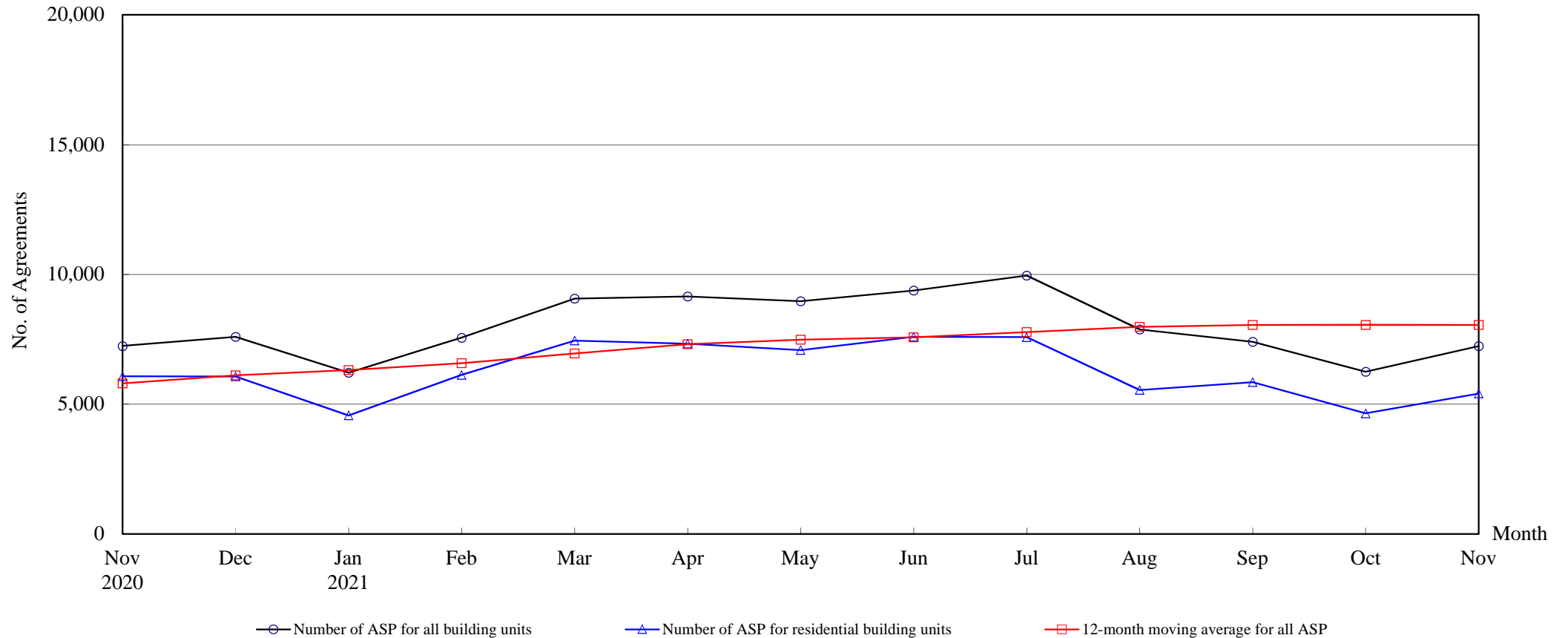

**building units from November 2020 to November 2021**



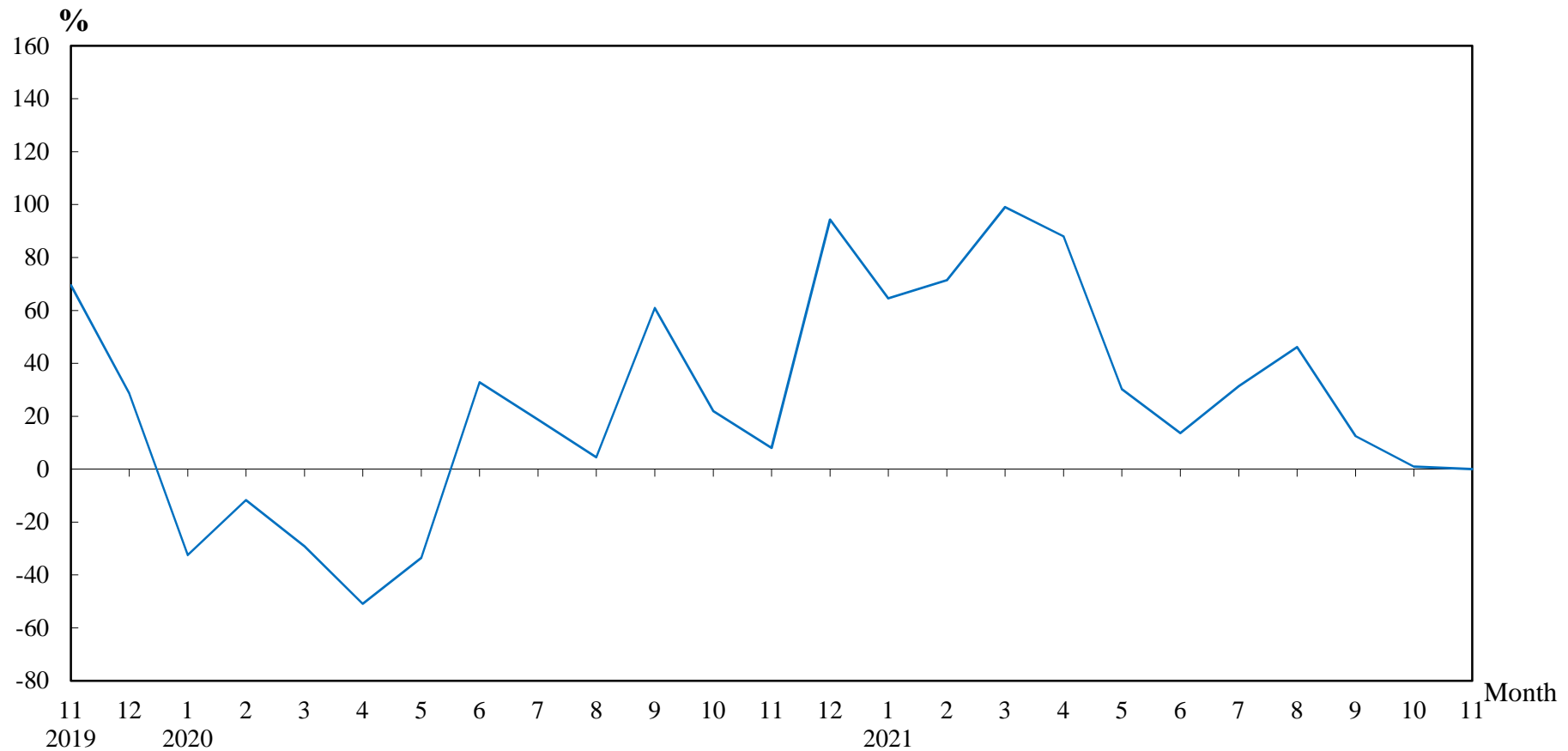
