Any person who had been present at Gin Teppanyaki and Sake, Shop A, G/F, Tse King House, 51/61 Kau Yuk Road, Yuen Long, New Territories, Hong Kong at any time during the period from 12:00 noon to 2:00 p.m. on 1 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 22 December 2021. If persons subject to compulsory testing have previously undergone testing between 18 December and 20 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at E-pai, teppan-yakitori, Shop G006, G/F, YOHO Mall I, 9 Yuen Lung Street, Yuen Long, New Territories, Hong Kong at any time during the period from 7:00 p.m. to 9:00 p.m. on 1 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 22 December 2021.
