Any person who had been present at Hong Kong Squash Centre, 23 Cotton Tree Drive, Central, Hong Kong at any time during the period from 4:00 p.m. to 9:00 p.m. on 7 December 2021, from 4:00 p.m. to 7:00 p.m. on 9 December 2021, or from 2:00 p.m. to 7:00 p.m. on 11 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 30 December 2021. If persons subject to compulsory testing have previously undergone testing between 26 December and 28 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 49. Any person who had been present at Kennedy Town Post Office, G/F, Kennedy Town Community Complex, 12 Rock Hill Street, Kennedy Town, Hong Kong at any time during the period from 2:00 p.m. to 7:00 p.m. on 8 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 30 December 2021. If persons

- subject to compulsory testing have previously undergone testing between 26 December and 28 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 50. Any person who had been present at Saizeriya Italian Restaurant, Shop 117, Podium level 1, The Westwood, 8 Belcher's Street, Shek Tong Tsui, Hong Kong at any time during the period from 11:00 a.m. to 3:00 p.m. on 8 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 30 December 2021. If persons subject to compulsory testing have previously undergone testing between 26 December and 28 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 51. Any person who had been present at Tower 6, The Belcher's, 89 Pok Fu Lam Road, Pok Fu Lam, Hong Kong for more than 2 hours at any time during the period from 6 December to 28 December 2021(including but not limited to residents, visitors and workers), has to undergo testing by 30 December 2021. If persons subject to compulsory testing have previously undergone testing between 26 December and 28 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## B. Others

(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notices)

1. Any person who had been present at BGCAHK Cheerland Nursery School cum Kindergarten (Wong Tai Sin), G/F, Tat Sin House, Upper Wong Tai Sin Estate, Wong Tai Sin, Kowloon, Hong Kong for more than two hours at any time during the period from 15 December to 28 December 2021 (including but not limited to full-time, part-time and relief staff, students and visitors) has to undergo testing by 30 December 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 26 December and 28 December 2021, they would be taken to have complied with the

If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before 16 December, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before 16 December, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before 16 December, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this published the Government's COVID-19 thematic (https://www.coronavirus.gov.hk/pdf/list of recognised covid19 vaccines.pdf).
