Details of Compulsory Testing Notice

A. Specified premises under additional testing

1. Any person who had been present at HK Diner, Shop S-126–S-127, 1/F, Zone S, H.A.N.D.S, 2A Tuen Mun Heung Sze Wui Road, Tuen Mun, New Territories, Hong Kong at any time during the period from 8:00 a.m. to 10:00 a.m. on 17 December 2021, from 8:00 a.m. to 10:00 a.m. on 20 December 2021, or from 8:00 a.m. to 10:00 a.m. on 21 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at ACE Restaurant, G/F, 46–48 Portland Street, Yau Ma Tei, Kowloon, Hong Kong at any time during the period from 3:00 p.m. to 5:00 p.m. on 20 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Taste Hong Kong, Shop 76, G/F, Melody Garden Commercial Complex, 2 Wu Chui Road, Tuen Mun, New Territories, Hong Kong at any time during the period from 10:00 a.m. to 12:00 noon on 16 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at Salami Restaurant, G/F, 294 Sha Tsui Road, Tsuen Wan, New Territories, Hong Kong at any time during the period from 7:00 p.m. to 9:00 p.m. on 14 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Wing Sing Cafe, G/F, 188 Reclamation Street, Yau Ma Tei, Kowloon, Hong Kong at any time during the period from 2:00 p.m. to 4:00 p.m. on 3 December 2021, or from 2:00 p.m. to 4:00 p.m. on 14 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject

to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

6. Any person who had been present at Classic Cafe, Shop 43 & 57, G/F, Melody Garden Commercial Complex, 2 Wu Chui Road, Tuen Mun, New Territories, Hong Kong at any time during the period from 10:00 a.m. to 1:00 p.m. on 7 December 2021, or from 10:00 a.m. to 1:00 p.m. on 14 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
7. Any person who had stayed at the General Outpatient Clinic of the Hospital Authority in Tuen Mun Wu Hong Clinic, 1/F, 2 Wu Hong Street, Tuen Mun, New Territories, Hong Kong at any time during the period from 8:00 a.m. to 1:00 p.m. on 13 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
8. Any person who had been present at Fairwood, Shop 65, Ocean Walk, 168–236 Wu Chui Road, Tuen Mun, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 11:00 a.m. on 2 December 2021, or from 9:00 a.m. to 11:00 a.m. on 10 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
9. Any person who had been present at 滋味餐廳小廚, Shop 68, G/F, Melody Garden, 2 Wu Chui Rd, Tuen Mun, New Territories, Hong Kong at any time during the period from 10:00 a.m. to 12:00 noon on 5 December 2021, from 10:00 a.m. to 12:00 noon on 9 December 2021, from 10:00 a.m. to 12:00 noon on 11 December 2021, from 10:00 a.m. to 12:00 noon on 15 December 2021, or from 10:00 a.m. to 12:00 noon on 18 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
10. Any person who had been present at temporary extension of Airport community testing centre, South Transition Deck, L6, Terminal 1, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 1:00 p.m. to 2:00 p.m. on 22 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022.

11. Any person who had been present at Midfield concourse, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong for more than 1 hour at any time during the period from 1 December to 23 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022.
12. Any person who had been present at Room 3T105, Terminal 1, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 12:00 noon to 2:00 p.m. on any day of 1 December to 23 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022.
13. Any person who had been present at Department of Clinical Oncology, Tuen Mun Hospital, Lower Ground, Radiotherapy Block, Tuen Mun Hospital, 23 Tsing Chung Koon Road, Tuen Mun, New Territories, Hong Kong at any time during the period from 8:00 a.m. to 10:00 a.m. on 17 December 2021, or from 8:00 a.m. to 1:00 p.m. on 20 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
14. Any person who had taken any of the Long Win buses running on route number E33 from Tuen Mun Central to Airport (Ground Transportation Centre) at any time during the period from 11:00 a.m. to 1:00 p.m. on any day of 1 December to 22 December 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
15. Any person who had taken any of the Long Win buses running on route number E33 from Airport (Ground Transportation Centre) to Tuen Mun Central at any time during the period from 11:00 p.m. to 11:59 p.m. on any day of 1 December to 22 December 2021, or from 0:00 a.m. to 1:00 a.m. on any day of 2 December to 23 December 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
16. Any person who had taken any of the Citybus buses running on route number S56 from Tung Chung Station to Airport (Passenger Terminal Building) (Circular) at any time during the period from 1:00 p.m. to 3:00 p.m. on 20 December 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 1 January 2022. If persons

subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

17. Any person who had been present at Yau Ma Tei Wholesale Fruit Market, Yau Ma Tei, Kowloon, Hong Kong at any time during the period from 2:00 p.m. to 4:00 p.m. on 20 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
18. Any person who had been present at Pharmacy, G/F, Main Block, Tuen Mun Hospital, 23 Tsing Chung Koon Road, Tuen Mun, New Territories, Hong Kong at any time during the period from 10:00 a.m. to 1:00 p.m. on 20 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

2. Any person who had been present at Fairwood, Shop No. 4, G/F, Ancillary Facilities Block, Shek Kip Mei Estate Phase 2, Kowloon, Hong Kong at any time during the period from 12:00 noon to 2:00 p.m. on 28 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had taken any of the KMB buses running on route number 2D from Chak On Estate to Tung Tau Estate at any time during the period from 10:00 a.m. to 11:00 a.m. on 28 December 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at JHC, Shop 17-19, G/F, Nam Cheong Centre, 89 Nam Cheong Street, Sham Shui Po, Kowloon, Hong Kong at any time during the period from 1:00 p.m. to 3:00 p.m. on 28 December 2021 (including but not limited to full-time, part-time and relief staff and visitors),

has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

5. Any person who had taken any of the Kowloon green minibuses running on route number 30B from Chak On Estate to Shek Kip Mei Station (Circular) at any time during the period from 1:00 p.m. to 3:00 p.m. on 28 December 2021 (including but not limited to full-time, part-time and relief staff and passengers), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
6. Any person who had been present at 135 Tuen Tsz Wai, Tuen Mun, New Territories, Hong Kong for more than 2 hours at any time during the period from 10 December 2021 to 30 December 2021 (including but not limited to residents, visitors and workers), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
7. Any person who had been present at Commune X, G/F, On Chuen Building, 10 Ming Ngai Street, Tuen Mun, New Territories, Hong Kong at any time during the period from 7:00 p.m. to 10:00 p.m. on 29 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
8. Any person who had been present at Broadway Cinema, L1-L4 Metroplaza, 223 Hing Fong Road, Kwai Fong, New Territories, Hong Kong at any time during the period from 7:00 p.m. to 11:00 p.m. on 28 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
9. Any person who had been present at Gyukaku Japanese Yakiniku Restaurant, Shop L1-18, 1/F, V City, 83 Tuen Mun Heung Sze Wui Road, Tuen Mun, New Territories, Hong Kong at any time during the period from 8:00 p.m. to 11:59 p.m. on 27 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Pizza Hut, 2/F, 168 Sai Yeung Choi Street South, Mong Kok, Kowloon, Hong Kong at any time during the period from 5:00 p.m. to 7:00 p.m. on 11 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at McDonald's, Shop 7T102, 8T005A and 8T005, Terminal 1, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 7:00 p.m. to 9:00 p.m. on 16 December 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by 1 January 2022. If persons subject to compulsory testing have previously undergone testing between 28 December and 30 December 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Students of the English School Foundation West Island School, 250 Victoria Road, Pok Fu Lam, Hong Kong (the Specified School) at Year 12 (the Specified Level) and teachers of the Specified School who had face-to-face lesson(s) with such students at the Specified Level, and who had been present at the Specified School for more than 1 hour at any time during the period from 9 December 2021 to 15 December 2021 (including but not limited to full-time, part-time and relief teachers) has to undergo testing by 1 January 2022.
