## Remarks

**Note 1:** HA currently adopts "Modular Flat Design" (MFD) and mainly provides four types of flats, including Type A (Internal Floor Area (IFA) of 14.1 to 14.5m²) for 1-or-2-person, Type B (IFA of 21.4 to 22.0m²) for 2-or-3-person, Type C (IFA of 30.2 to 31.0 m²) for 3-or-4-person, and Type D (IFA of 35.0 to 36.1m²) for 4-to-5-person.

**Note 2:** In general, occupation permit (OP) can be obtained about two to three months after project completion. However, there were individual cases in the past that, due to the complexity of the projects, the performance of contractors, or being affected by COVID-19 epidemic, etc., required a longer duration for the preparation of the application of OP. Upon the issuance of OP for newly completed PRH estates, HA will issue offer letters to prospective tenants within one to two weeks for completion of the intake formalities in estate office. For subsidised sale flats, about one to two months after the issuance of OP for new developments, HA's appointed solicitors will, in accordance with the terms of the Agreement for Sale and Purchase, notify purchasers in writing for payment of the balance of purchase price and completion of sale and purchase within a specified period.
