

Biographies of Expert Advisors of the Task Group on New Medical School

Professor Grace Tang Wai-king

Professor Tang is the current Chairman of the Medical Council of Hong Kong. She is an Honorary Clinical Professor of Obstetrics and Gynaecology at the University of Hong Kong, a pioneering advocate for women's health, and a respected leader in medical education. Professor Tang has previously served as the Dean of the Faculty of Medicine of the University of Hong Kong and the President of the Hong Kong Academy of Medicine.

Professor Gilberto Leung Ka-kit

Professor Leung is the current President of the Hong Kong Academy of Medicine. He is a neurosurgeon, currently serving as the Associate Dean (Teaching and Learning) of the LKS Faculty of Medicine of the University of Hong Kong and the Tsang Wing-Hing Professor in Clinical Neuroscience. He is also an Honorary Consultant Neurosurgeon at Queen Mary Hospital.

Professor Joseph Sung Jao-yiu

Professor Sung is the current Dean of the Lee Kong Chian School of Medicine and Senior Vice-President (Health and Life Sciences) of Nanyang Technological University, Singapore. He is a renowned researcher in gastroenterology and hepatology and has previously served as the Vice-Chancellor and President of the Chinese University of Hong Kong (CUHK) and the Associate Dean of the Faculty of Medicine at CUHK.

Professor Nivritti Gajanan Patil

Professor Patil is currently the Vice Dean of the Faculty of Medicine of the Macau University of Science and Technology and Visiting Professor at various medical schools in the Greater Bay

Area. He is a key figure in the development and implementation of the curriculum of the new Medical School of the Macau University of Science and Technology. He was Honorary Clinical Professor and Advisor to the Dean of the LKS Faculty of Medicine of the University of Hong Kong.

Professor Zhao Yupei

Professor Zhao is an expert in clinical surgery and an academician of the Chinese Academy of Sciences. He is currently the President of the Chinese Medical Association and the Honorary President of Peking Union Medical College Hospital. For more than 40 years, Professor Zhao has been working on the frontline of clinical practice, research, and teaching in general surgery, and has actively promoted international academic exchange in the field, greatly contributing to the advancement of the nation's academic standards in surgery. Professor Zhao previously served as the President of Peking Union Medical College Hospital.

Mr Philip Tsai Wing-chung

Mr Tsai is a certified public accountant with over 35 years of experience in the accounting profession. He is currently a member of the University Grants Committee and holds several positions in the field of public health, including as a member of the Hospital Authority (HA) Board, Chairman of the Hospital Governing Committees of Queen Mary Hospital and Tsan Yuk Hospital, Chairman of the Supplementary Medical Professions Council, Chairperson of the Board of Directors of the Hong Kong Genome Institute, and a member of the Advisory Board of the Hong Kong Red Cross.
