Supplementary information

- (i) The above statistics include cases of occupational injuries and deaths of nonskilled workers reported to the Labour Department by contractors of the four major procuring departments in the past three years. There was no case of industrial accident¹ and occupational disease recorded by the said contractors in the past three years.
- (ii) Among the above statistics, there were two cases involving fatality of three non-skilled workers in 2022-23. One case involved a traffic accident resulting in the death of two workers. As for the other case, the cause of death of an employee was related to his/her underlying disease.
- (iii) The four major procuring departments do not compile statistics on the average number of days of sick leave taken by outsourced non-skilled workers due to work injury in the past three years.
