<u>Appendix 1</u> <u>Key Information of the Hong Kong-Shenzhen Western Rail Link (Hung Shui</u> <u>Kiu-Qianhai) (HSWRL) Project</u>

The HSWRL is approximately 18.1 km long, with the Hong Kong section and the Shenzhen section being about 7.3 km long and 10.8 km long respectively. The alignment will start from the west of Hung Shui Kiu Station under construction on the Tuen Ma Line, passing through Ha Tsuen and Lau Fau Shan, crossing Deep Bay and connecting to Qianhai via Shenzhen Bay Port. It is an underground railway line comprising a total of five stations, with three stations in Hong Kong located in Hung Shui Kiu, Ha Tsuen and Lau Fau Shan respectively and two stations in Shenzhen located in Shenzhen Bay Port and Qianhaiwan respectively. The depot will be located at Ha Tsuen.
