Any person who considers that he has an interest, right or easement in or over the foreshore and sea-bed so described may, by notice in writing delivered to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of two months from the date of this notice, object to the proposed undertaking. The notice of objection shall describe the interest, right or easement of the objector and the manner in which he alleges he will be affected.

SCHEDULE

Foreshore and sea-bed affected

Approximately 240 hectares of foreshore and sea-bed situated at Lung Kwu Tan as delineated and shown edged red on a plan, numbered TMM4717, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

- (i) Ground improvement and filling of the sea-bed to form approximately 145 hectares of land;
- (ii) Reprovisioning of a submarine outfall of approximately 2 400 millimetres in outer diameter and approximately 1 000 metres in length from the shore of new land by ground improvement and dredging of approximately 10 metres below the sea-bed which will be reinstated by backfilling with crushed rocks; and
- (iii) Construction of seawall.


