Note 1 : Applications approved in a year may not totally be the applications received in the same year.

Note 2 : Starting from November 1, 2024, the ImmD has allowed successful applicants under the TTPS to apply for extension of visa three months before the expiry of their visas. The numbers include applications received in advance by the ImmD for extension of visa under the TTPS between November 1, 2024 and December 31, 2024.

Note 3 : The number of applications approved denotes the number of applications that passed the selection by the Advisory Committee on Admission of Quality Migrants and Professionals or the Government's Assessment Panel.

Note 4 : The New Capital Investment Entrant Scheme was launched on March 1, 2024.

Note 5 : The numbers denote the numbers of received and approved applications for visas/entry permits that were submitted to the ImmD after the applicants had obtained the Certifying Proof for Fulfillment of Net Asset Requirement issued by Invest Hong Kong (InvestHK). Applicants who were given "Approval-in-Principle" could enter Hong Kong on visitor status for not more than 180 days for making the committed investments.

Note 6 : The numbers denote the numbers of received and approved applications for visas/entry permits after the applicants had obtained the Certifying Proof for Fulfillment of Investment Requirements issued by InvestHK, and submitted the said proof to the ImmD for resuming the processing of their applications.
